



Thanks to Margaret C. Costa, Secretary to Judge Alaimo, to submitted the following article from the May 1991 issue of the Court Administration Bulletin, as a timely reminder to those who travel, whether frequently or infrequently, for either business or personal purposes (like the San Diego Conference!)

PERSONAL SECURITY

The recent brutal, violent murder in a Detroit hotel room of an airline flight attendant prompted the following personal safety guidelines for employees who stay in hotels while traveling:

If you receive a call from the front desk regarding a maintenance problem in your room, or changing your room, never assume it's legitimate.

Never open your door to a stranger.

Never verbalize your room number to anyone in the lobby or elevator.

If you are staying with a group of people at the same hotel, have a "buddy system" for checking rooms.

At check-in, ask for adjacent rooms with someone you know.

Never leave your door ajar while you go to the ice/soda machine.

If you intend to leave your room for any length of time and your room door is not within your view, attach a piece of tape to the bottom of the door and to the door frame to ascertain if anyone has entered your room. Also, a matchstick wedged between the door and door frame could work just as well.

If you are uncomfortable having someone enter your room to deliver food, have them leave it outside your door.

Use good judgment before opening your door from the outside. If there is another individual nearby or approaching you, put your key in your pocket and keep walking until the area around your room is clear.



FOLLOW-UP ON THE HAY GROUP STUDY AND THE PRESENT STATUS OF OUR QUEST FOR JSP UPGRADING

The Hay Group submitted its report and recommendations to the Administrative Office this past spring. The report suggested major revisions to nearly every aspect of the JSP system. Just prior to the Hay Group study being circulated to all judges and heads of agencies for their comments, the AO had the report pulled. Now the AO, due to the magnitude and far-ranging significance of the major changes recommended by the Hay Group, has developed a new time schedule for proceeding with the study of the JSP system. According to the Administrative Office, quoting from the June 1991 Court Administrative Bulletin, this "would allow a more thorough and deliberate assessment of alternative systems; establish an approach to allow adequate input from all court managers; and allow time to carefully examine all of the issues involved in the many subsystems that comprise the JSP."

It is anticipated that the study and recommendations would be presented to the Judicial Resources Committee in June 1991 and thus allow any final recommendations to be considered by the Conference in the fall of 1993. Any implementation would begin in January 1994.

As far as the FJSA quest for a JSP-12, we endorsed and concurred by letter in the resolution presented to the Judicial Resources Committee by the Association of Bankruptcy Judges' Secretaries. The resolution and our letter endorsement were submitted for presentation to the committee at their meeting in June. Unfortunately, it did not become an agenda item. We also gamered support from a majority of the Chief Judges at their meeting in May. At this time we are not sure where their supporting resolution stands, but hope to have some information to report at our conference in October. In the development stages is support by another committee of the Judicial Conference of the United States. More on this aspect at the Conference. We have been in contact again with the Association of Bankruptcy Judges' Secretaries and believe we should submit a joint resolution to the Judicial Resources Committee for their meeting in December. More about this at the Conference. I hope to see you there!



Clifford Wallace, Chief Judge of the Ninth Circuit Court of Appeals, was on hand to welcome and introduce us to southern hospitality, California style.

Mike Monahan, President of Management Resource Associates, took us on a trip into the "21st Century Workplace" where the work week does not get shorter, but because of the advanced technology the tendency is to work more hours to get even more done. The working man with family at home in 1960 was 70% and in 1990 is now 7%. He stressed getting in touch with

#### PRESIDENT'S MESSAGE



#### LIFE INSURANCE COVERAGE AFTER RETIREMENT

The following letter was received December 30, 1991, from Carol Sefren, in response to some questions which were raised during her discussion at the San Diego conference.

I thank the Association for inviting me to speak on personnel issues at its conference in San Diego. I had a wonderful time and enjoyed visiting with everyone. I apologize that I have not been able to get you the information on life insurance coverage following retirement any sooner than this and hope that it's not too late to publish it in your newsletter.

In order for an employee to continue his or her Federal Employees' Group Life Insurance coverage after retirement, either under the Civil Service Retirement System (CSRS) or the Federal Employees' Retirement System (FERS), the employee must have been continuously covered under the Federal Employees Group Life Insurance (FEGLI) program for the last five years immediately before retirement or from his or her first opportunity to be enrolled, if less than five years.

If eligible for coverage as a retiree, Basic Life and any of the options in effect at the time of retirement will automatically be continued unless the employee voluntarily elects to cancel life insurance or the employee decides to convert the coverage to an individual policy. If an employee decides to cancel life insurance coverage, the employee will need to complete a Standard Form 2817, Life Insurance Election Form, cancelling coverage and submit this form along with his or her application for retirement. An employee who voluntarily cancels life insurance coverage is ineligible to convert the insurance to an individual policy. An employee who decides to convert the coverage to an individual policy would need to contact the Office of Federal Employees' Group Life Insurance in New York for information on a conversion policy. The instructions for requesting a conversion policy are on the Standard Form 2819, Notice of Conversion Privilege, which will be issued to the retiring employee at the time of his or her retirement.

If the employee decides not to cancel life insurance coverage or to convert such coverage, he or she can elect to continue 100 percent, 50 percent or 25 percent of the Basic Life amount in effect at the time of retirement. The Basic Life insurance amount and the premiums will vary depending on the percentage of continued coverage the employee elects. The three levels of post-retirement Basic Life insurance coverage are:

- 25 percent (minimum) level of coverage. Effective with the date of retirement, the monthly premium with-holding will be \$.401 for each \$1,000 of Basic Life insurance coverage, if under age 65. At age 65 there will be no premium charge, however, the Basic Life insurance amount will automatically begin reducing at 2 percent each month until it reaches 25 percent of its face value.
- 50 percent level of coverage. Effective with the date of retirement, the monthly premium withholding will be \$.921 for each \$1,000 of Basic Life insurance coverage, if under age 65. At age 65, the monthly cost per \$1,000 will reduce to \$.52 and the Basic Life insurance amount will begin reducing at 1 percent each month until it reaches 50 percent of its face value.
- 100 percent level of coverage. Effective with the date of retirement, the monthly premium withholding will be \$2.091 for each \$1,000 of Basic Life insurance coverage, if under age 65. At age 65, the monthly cost for each \$1,000 will reduce to \$1.69 and there is no reduction in the amount of insurance.

If the retiring employee elected Option A-Standard coverage for \$10,000, full coverage is retained until age 65 or until the employee retires if over 65, at which time coverage begins reducing by 2 percent each month until it reaches its final value of \$2,500. The monthly premium charge for this coverage will vary with the age of the annuitant but in any event the premiums stop at age 65.

If the retiring employee elected Option B-Additional coverage, the amount of coverage will be the employee's annual salary immediately before retirement rounded up to the next \$1,000, times the number of multiples the employee elected. Beginning at age 65 or at retirement, whichever is later, the amount of Option B-Additional insurance will begin reducing at 2 percent a month for 50 months, at which time all coverage will terminate. The cost for this coverage will be at the same rate that the retiree was paying before retirement but the premiums will be calculated on a monthly basis rather than a bi-weekly basis. Premiums will be withheld from annuity payments until age 65. No further withholdings are required after the retiree becomes age 65.

For those retiring employees who elected Option C-Family insurance, beginning at age 65 or at retirement, whichever is later, the amount of coverage will begin reducing at 2 percent each month for 50 months, at which time all coverage will terminate. Monthly premiums will be withheld from annuity payments until age 65. No further withholdings are required after the retiree becomes age 65.

I hope this information will provide assistance to the Association in explaining the Federal life insurance benefits available after retirement and the cost associated with the various options. If you have any questions or if I can be of further assistance, please call me at FTS 633-6474.

At its meeting on December 4 and 5, the Committee considered your proposals to increase the grade of judges' secretaries and to change the official title of record for your positions. After much deliberation, the Committee decided to take no action on the proposals at this time.

As you know, the courts are in the midst of a major study of the overall Judiciary Salary Plan job classification and pay systems. It was largely in light of this that the Committee decided that there is insufficient basis for taking favorable action at this time on your proposals. For the same reason, the Committee decided not to take action on a large number of other proposals as well, many of which were requested by other Committees of the Judicial Conference.

The Committee members appreciate your bringing to their attention the strong sentiment among judges' secretaries in favor of changes to pay and title for the position. Such input from employee organizations is of special value in the ongoing study of our job classification and pay system.

Many judges wrote letters in support of your proposals. I would appreciate any assistance your associations can provide in informing your membership of the Committee's decision, so that they can inform their judges of the outcome of the issue.


#### ELEVENTH CIRCUIT - Rosemary Giachinta, Repr.

Beverly just returned from a short weekend tour to St. Petersburg, Russia. Even though the trip was short, it certainly sounds like she had a great time. Her comments about her trip are as follows:

After boarding a Finnair wide-bodied L1011 in New York, we traveled seven hours and ten minutes to Helsinki and changed planes for the 45-minute flight to St. Petersburg. Our hotel was clean and comfortable. We splurged on one meal at a newly opened hotel run by the Swedish. The mean was comparable to the finest in America. Generally, the food is different from what we are used to, but there was always something we could eat. The water was not potable, and we kept bottled water in our room. We never felt a moment of hostility towards us — quite the opposite. The people seemed to be looking out for our welfare, and happy that we were there. We were able to use U.S. currency (called hard currency) everywhere except in Ruble stores.

The temperature was in the 30s and it rained a little one day.

This city of several million people has no single-family homes, only apartments, and sometimes several generations share one small apartment. They do not have refrigeration, and must shop for food daily. We saw lines at the bread store and at the milk store, etc. We were struck with the number of pedestrians on the streets. The sidewalks were very crowded, with people often standing in lines or milling about.

The young people are very enthused about private ownership in farming and business, and some expressed a desire for their political leaders to be professionals such as lawyers and scholars.

We saw two ballets, St. Isaac's Cathedral, Heritage's extensive collection of art, had a city tour, did some souvenir shopping, and took a side trip to Pushkin (we saw where the Nazi invasion was stopped before reaching St. Petersburg.) The last night was a gala dinner and floor show. We thoroughly enjoyed each event and felt the trip was long enough, considering the pace.

In saying goodbye to our guide we asked, "What can we as American citizens do for you?" Her eyes filled with tears, and after she got control, she said, "We are trying very hard to give good value for the dollar. Tell American people they can help Russian people by coming to visit."



The Judicial Conference's Committee on Judicial Resources, of which I am the chair, recently held its semi-annual meeting to consider personnel policy matters affecting court employees. I am writing you because at this meeting the Committee reconsidered a request that originated with your associations some time ago, namely, a request to increase the grade level for judges' secretaries.

We considered this request at our meeting last December as well. Although we all value our secretaries highly, after much deliberation we were unable to recommend an upgrade of the position. We reported this decision to the Judicial Conference, and I attended the Conference's meeting last March to explain the Committee's decision. Members of the Conference discussed the issue at length also and finally asked me to take the matter back to the Judicial Resources Committee for reconsideration and alternatives, which I was happy to do. pagain extensive. We looked at your request in terms of pay, not just in terms of grade level, and found that secretaries salaries have increased rapidly over the years being in a grade-and-step pay system (a secretary appointed at JSP-10 in 1959 has had her pay increased by 298% by 1992). The Committee concluded that your salaries appear fair in light of comparable salaries and strict budget constraints, and we once again were unable to vote

We recognize that, because your employment is so closely connected with that of your judges, many of you feel vulnerable, knowing that you may suffer a pay reduction or lose your job when your judge's time in office ands. 
