# Greetings!

On November 1, 2010, I assumed the position of Treasurer of our wonderful organization and acquired documents maintained by numerous prior treasurers. It has been an interesting and exciting adventure going through those documents. At the beginning of my tenure, \$10,000 was transferred into our new checking account with JPMorgan Chase Bank, N.A. Sad news from our Circuit. Dorothy Williams, former judicial assistant to Circuit Judge Levin H. Campbell, died on Friday, May 20, 2011, at her home in Wakefield after a 16-year courageous battle with cancer. She was 59 years old. Dorothy began working for the Federal Government as an Administrative Assistant with the Environmental Protection Agency where she worked for ten years. For the last 25 years, Dorothy had been Circuit Judge Campbell's Judicial Assistant, and had recently retired. Dorothy enjoyed knitting and reading, but most of all she enjoyed spending time with her family, especially her five grandchildren who she adored. Dorothy will be dearly missed, especially by those who she touched and encouraged in their own personal battles with cancer while undergoing her own. May she rest in peace.

The only judge from Maine on the First Circuit Court of Appeals will assume senior status later this year. Appellate Judge Kermit Lipez, 69, of South Portland, has been a First Circuit judge since 1998. He says that he plans to transition from active status on December 31 or when his successor is confirmed, but will maintain a full caseload. "Senior status is not retirement," Lipez said recently from his office in the Edward T. Gignoux United States Courthouse in Portland. "I'm not retiring and I've indicated this to my chief judge and to the president and to the congressional delegation. [Senior status] means that over time, I can gradually reduce my work schedule and, possibly, devote more time to teaching and writing." Judge Lipez was nominated to the federal bench by President Bill Clinton in August 1997 while on the Maine Supreme Judicial Court. Lipez replaced Judge Conrad K. Cyr, of Bangor. "I will turn 70 in August," Lipez said, "and I think there is an unspoken but sound tradition in Maine that that is the time for a change in status. It is a privilege to do this work and I think the privilege should be shared with others." Congratulations and good luck Judge, as you continue and embark in your "old" and new endeavors.

# District of Puerto Rico

Sad news from our District. Senior U.S. District Judge Jaime Pieras, Jr., passed away on June 11, 2011, at his home in Condado, San Juan, after having been diagnosed with terminal cancer several months ago. Judge Pieras was born in San Juan, Puerto Rico. He obtained a B.A. from Catholic University of America in 1945 and his J.D. from Georgetown University in 1948. He served as a Second Lieutenant in the United States Army immediately after World War II, from 1946 to 1947. Immediately after his graduation from law school, he entered private practice in Puerto Rico in 1949 until 1982, when nominated to the bench. He was appointed as a Federal District Judge in the District of Puerto Rico by President Ronald W. Reagan in 1982, and was confirmed by the United States Senate on July 14 of that year. He received his commission the following day. On August 1, 1993, Judge Pieras assumed senior status but continued to manage a full case load until he fell ill.

(Cont'd) On June 15, the district court held a memorial service in the Clemente Ruiz-Nazario Courthouse, where the state and federal judiciary, as well as various representatives from state and federal government agencies and friends, paid Judge Pieras their final respects. As stated by Chief Circuit Judge Sandra Lynch in part of her message, delivered through Chief Judge Delgado, "Judge Pieras demonstrated a commitment to excellence that came from a deep sense of loyalty to the values of our country. His work improved our system of justice. He developed a case management system, the Initial Scheduling Conference method, that was ultimately codified in the Federal Rules of Civil Procedure. He constantly sought to reduce costs and eliminate unnecessary delays – efforts all federal judges employ today." We extend our deepest sympathy to his family and his court staff. He will be greatly missed and fondly remembered by all of us – his court family.

On other more positive news, we congratulate attorney Silvia Carreño-Coll, who was recently unanimously designated as United States Magistrate Judge in our District. Ms. Carreño-Coll is currently the EPA's Associate Regional Counsel for Caribbean Programs in San Juan. She received numerous awards from the USDOJ, other federal agencies, and the Government of Puerto Rico for her zealous litigation in support of the agency's mission to safeguard the natural environment by enforcing compliance of federal statutes and agency sanctions. With approximately 25 years of civil and criminal federal litigation experience in the administrative, trial, and appellate fora, Ms. Carreño-Coll brings a wealth of experience to the position of United States Magistrate Judge. A naturalized United States citizen since 1976, she graduated cum laude from both Emerson College, in Boston, Massachusetts, and the University of Puerto Rico School of Law. Her trajectory in the legal profession within the public service arena attests not only to her able skills as an attorney, but to her temperance and character, and her personal commitment to the principles of justice. Marirosa Cabrera, presently a Courtroom Deputy Clerk at the Clerk's Office, will join Ms. Carreño-Coll in chambers as her Judicial Assistant.

# COURT OF APPEALS:

On April 12, 2011, there was an unveiling of a wonderful portrait of the Honorable José A. Cabranes, U.S. Court of Appeals, during a Ceremonial Session of the District Court of Connecticut. Judge Cabranes' law clerks (1979 to present) commissioned his portrait. The Master of Ceremonies, Jesse Furman, a former law clerk, was quick to point out that although Judge Cabranes has no immediate plans to assume senior status or retire, the law clerks felt it was an appropriate time to honor him. And honor him they did! The artist, Mark Daniel Duffy, is a very talented artist who has studios in CT and in Ireland. Mr. Duffy did an amazing job incorporating many facets of Judge Cabranes' life within the portrait. Following the unveiling, the law clerks treated over 200 in attendance to a lovely reception. The Honorable Wilfred Feinberg will be celebrating 50 years on the Federal Bench and his 91st birthday on June 22. Judge Feinberg has had a long, impressive career as a well-respected jurist on this Circuit. Among his many famous cases, Judge Feinberg was a member of the panel which heard the Pentagon Papers case. The Pentagon Papers have now been released in their entirety to the public. 

# **DISTRICT OF CONNECTICUT:**





On May 2, 2011, to celebrate Law Day, the Public Outreach Committee of the United States District Court for the District of Connecticut hosted programs for local students at the courthouses in Hartford, New Haven and Bridgeport. Law Day is a national day of celebration, officially designated by a joint resolution of Congress in 1961, that focuses on our heritage of liberty under the law. This year's Law Day theme was "Living in the Land of the Free: Freedom and Responsibility." Tenth graders from Central High School in Bridgeport (Anne Engelson, Principal), Hill Regional Career Magnet High School in New Haven (Michael Ceraso, Principal), and Law & Government Academy in Hartford (Adam Johnson, Principal) came to the federal courthouse in their city to participate in a true-to-life trial simulation to foster their understanding of the trial process and the role of our federal courts in resolving disputes. Grade school students also created original works of art to be displayed in the courthouses expressing what it means to them to be living in the land of the free. The schools participating are Thomas Hooker School in Bridgeport (Lourdes Delgado, Principal), Davis Street Arts and Academics School in New Haven (Lola Nathan, Principal), and John C. Clark School in Hartford (Williams Chambers, Principal).

This year's Law Day activities were part of a larger effort by the Public Outreach Committee to educate young people and the public to the important role that the Federal Courts, our Judges and lawyers play in preserving the rule of law and promoting the freedoms we have often come to take for granted. Said Chief Judge Alvin W. Thompson of the Public Outreach Committee, "Our goal is to help students and other members of the public develop a better understanding of the importance of the rule of law in a country that was founded based on the ideals of justice and liberty for all. We also wish to promote a better understanding of the civil and criminal justice systems. We hope our theme for Law Day will prompt students to think about the important relationship between the freedoms they enjoy as the result of growing up in this country and the responsibilities of citizenship."

The trial simulation used this year involves an issue familiar to high school students – texting while driving. It was based on a real civil case that was decided by the United States Supreme Court, involving a car crash that may have been caused by driving while texting. The trial simulation was scripted, and the students were afforded the opportunity to play meaningful parts, as counsel, witnesses and jurors. Local attorneys and court personnel volunteered to visit the students at their schools to prepare them for the trial simulation.

The trial simulation programs were held on May 2 in the Brien McMahon Federal Building in Bridgeport, at the Richard C. Lee Courthouse in New Haven, and at the Abraham Ribicoff Federal Building in Hartford. The original works of art were on display in these courthouses from April 27 through May 13, 2011.

Hats off to all involved in this wonderful Law Day program! A great job well done! I wish everyone a wonderful, relaxing summer!

# THIRD Circuit



I am pleased to inform you that two Magistrate Judges, Claire C. Ceechi and Esther Salas, were recently elevated to District Judges by commission of President Barack Obama. Both were nominated by Senators Frank R. Lautenberg and Robert Menendez and confirmed by the full Senate.

Judge Cecchi was appointed Magistrate Judge on April 26, 2006. Prior to her appointment, Judge Cecchi was a partner at McElroy, Deutsch, Mulvaney & Carpenter, LLP. She is a Fellow of the American Bar Association, a Director to the Historical Society of the United States District Court for the District of New Jersey, and a Master of the William J. Brennan, Jr./Arthur T. Vanderbilt American Inn of Court, 2009. Judge Cecchi was nominated by President Barack Obama to fill the seat vacated when Judge Joseph Greenaway was elevated to the Third Circuit Court of Appeals. Judge Cecchi received her B.A., cum laude, from

from Barnard College, Columbia University, and her J.D. from Fordham University School of Law.

Esther Salas was appointed Magistrate Judge on November 6, 2006. She began her career as a clerk for Judge Eugene Codey and later became an associate at Garces & Grabler P.C., from 1995 to 1997. From 1997 to 2006, Judge Salas worked as an Assistant Public Defender for the District of New Jersey. Judge Salas fills the seat vacated by Judge Katharine Hayden.

Judge Salas earned her B.A. in 1991 from Rutgers University and her J.D. in 1994 from the Rutgers University School of Law at Newark.

The Judges of the District Court in the Eastern District of Pennsylvania, along with the District Court Historical Society, recently unveiled the Portrait of Chief Judge Harvey Bartle, III, in the Ceremonial Courtroom of the District Court in Philadelphia. Judge Bartle has served the judiciary since 1991, having been nominated by President George H.W. Bush. In 2001, Chief Justice William Rehnquist appointed him as a member of the Criminal Rules Committee and in 2008, he was elected as the District Judge Representative to the Judicial Conference from the Third Circuit. Chief Justice John Roberts named him in 2010 to the Judicial Conference Executive Committee. Judge Bartle also sits on the Judicial Council of the Third Circuit.

Angela will be attending the Community College of Sierra Vista, AZ and Emily is going to Baylor University in Texas. # **SIXTH Circuit**

# **Patent Pilot Study**

The U.S. District Court for the Western District of Tennessee is one of fourteen federal district courts selected to take part in a 10-year pilot project designed to enhance expertise in patent cases among U.S. district judges. To be eligible to participate, courts had to be among the 15 district courts in which the largest number of patent and plant variety protections cases were filed in 2010, or be district courts that adopted or certified to the Director of the Administrative Office of the United States Courts (AOUSC) the intention to adopt local rules for patent and plant variety protection cases. The pilot, mandated by Pub. L. No. 111-349, begins in July. Chief Judge Jon P. McCalla and the Honorable S. Hardy Mays are the judges designated to hear patent cases during the pilot.

# Camera Pilot Study

In September 2010, the Judicial Conference authorized a three-year pilot project to evaluate the effect of cameras in district court courtrooms, video recordings of proceedings and publication of such video recordings by making them available through www.uscourts.gov as well as participating courts' websites, if desired. The US District Court for the Western District of Tennessee is one of fourteen federal trial courts selected to take part in the Federal Judiciary's digital video pilot, also known as the Cameras in Court Pilot Study. # Chief Judge McCalla (TNWD) Releases History Book

After more than nine years in research, writing, and production, and containing 608 pages including 883 photographs, maps, and illustrations, *An Illustrated History of the People and Towns of Northeast Shelby County and South Central Tipton County - Salem, Porters-ville, Idaville, Kerrville, Armourtown, Bethel, Tipton, Mudville, Macedonia, Gratitude, Barretville, and Rosemark, Tennessee was released to the public by Chief Judge Jon P. McCalla, Western District of Tennessee. Chief Judge McCalla edited the book along with Managing Editor Penny Saucier Gloves and Co-Editors Ruth Blakey Billingsley and Louise Wooldridge Rhodes. The book begins with a brief sketch of the pre-history of the area and, through a series of articles and interviews, tells in detail the story of the people, enterprises and churches of the area. The book serves as the first comprehensive history of the towns and farms of this largely rural area.*

# Honorable James M. Fitzgerald

Hon. James Fitzgerald passed away on April 3, 2011 at age 91 after a lengthy and distinguished judicial career. Judge Fitzgerald was an original member of the Alaska Territorial Bar and legal pioneer in Alaska. He was a vital part of the Alaska transition from territory to statehood. Judge Fitzgerald served as one of the eight original state court judges and on the Alaska Supreme Court before being appointed to the U.S. District Court in 1974 by President Gerald Ford. In addition to his legal career, Judge Fitzgerald served honorably in the U.S. Marine Corps and was present in Hawaii in 1941 to play a college football game when Pearl Harbor was bombed and every member of the football team was conscripted and put on duty. Judge Fitzgerald will be long remembered for his dedicated service to Alaska's judiciary.



A dedication and naming ceremony for the John C. Godbold Federal Building was held recently in Atlanta, Georgia, at the 11th Circuit Court of Appeals headquarters. The building was dedicated in honor of the late Judge John C. Godbold, who served in the 5th Circuit. When the 5th and the 11th Circuit divided, he became the only person ever to have served as Chief Judge of two circuits. The John C. Godbold building is located in the Fairlie Poplar National Historic District in downtown Atlanta. The challenge in renovating the property acquired by GSA was to bring the 100-year old building structure into the modern work environment. The commitment by GSA to reduce the building's environmental "footprint" is reflected through the building's ambitious energy performance goals, the reduction of greenhouse gas emissions, the elimination of toxic substances, and the recycling of construction waste, resulting in over 2500 tons or 80% of the demolition debris and construction waste being diverted from landfills. Remnants of the historic building "fabric" are exposed as a reminder of the historic nature of the building and as a contrast with the modern interior finishes.

Judge Jerome Farris sat with the 11th Circuit recently at an Atlanta court sitting. He kindly told me that Judge Anderson had been talking about me at lunch - you know, the usual small talk about me being with Judge Anderson for so long. I told Judge Farris that I had spoken with his Judicial Assistant, Kelly, and she seemed like a very nice person. He said that she was the daughter of his first secretary, who retired after 25 years with him. Judge Farris told his first secretary that he could never replace her so he would be happy to have her daughter work for him, and he hired

her! I asked him if he was going to go for the granddaughter, too, to which he laughed and said he thought this would do it for him! He also said he bet they were the only mother/daughter team that had worked for a federal judge, and I told him that he was probably correct.

# Farewell to Judge Cynthia Holcomb Hall

On February 26, 2011, at 4:30 in the morning, Judge Cynthia Hall died peacefully in her sleep after a lengthy battle with multiple myeloma. She had celebrated her 82nd birthday one week previously. Although she will no longer be sitting with her colleagues, traveling with her friends, providing guidance to young lawyers, attending special family events, or toasting the finer things in life with her latest wine discovery, her legacy will continue.

Among the pioneer women in the legal field, Judge Hall graduated from Stanford University Law School in 1954 and became a law clerk to Judge Richard H. Chambers, then newly appointed to the Ninth Circuit. She said of that first job as an attorney:

"I still recall discussing cases with the judge in his chambers with his door closed while he smoked and chewed on a cigar. By the time we finished, the room was blue with smoke and I had a headache, but you can be sure I did not say a thing because I was so grateful to have a job." (Western Legal History: The Journal of the Ninth Judicial Circuit Historical Society, 19, 2006, p 55).



Judge Hall's career developed rapidly, if not smoothly, after that with her appointment to the Tax Division of the Department of Justice and the Office of Tax Legislative Counsel, Department of the Treasury, in Washington, D.C. She then spent four years as a partner with the law firm of Brawerman & Holcomb in Beverly Hills before she was appointed to the United States Tax Court in 1972. Judge Hall was elevated to the United States District Court for the Central District of California in 1981 and to the United States Court of Appeals for the Ninth Circuit in 1984.

It was in October of 1988 that I met her for the first time when I interviewed for the job. I was impressed then by the quietly regal atmosphere of the Pasadena courthouse, particularly the lovely garden setting. I did not know at the time that Judge Chambers was a driving force in making the former hotel/hospital into a courthouse which was later named in his honor, or that Judge Hall was the undisputed power behind the grounds. From the first landscape plans, through the rebuilding of the entrance pergola, to supervising placement of every tree, shrub, and flower, she was dedicated to providing beauty for residents and visitors to enjoy. I learned far more botanical terms than I will ever use transcribing her flower alerts to be sent to the judges and staff with Judge Hall's recommendation that they all take time, literally, to smell the roses.

In addition to her penchant for gardening, Judge Hall was an excellent amateur photographer, an avid birder, and an extensive world traveler. Some of her court assignments allowed her, and by extension me, to combine all of these hobbies into some pretty impressive and exciting trips. In addition to our own Ninth Circuit sittings in Anchorage, Honolulu, Seattle, and Portland, we were privileged to attend a calendar in Guam in 1994, and experienced a harrowing landing during a typhoon. During that visit, we took a side trip to Saipan and were caught in another tropical storm on a ferry following a luau on a neighboring island where we snorkeled coral reefs and saw amazing colorful fish. In addition, we attended the formal ceremonies for Palau's independence celebration which had VIPs in full native dress from numerous South Pacific nations.

After Judge Hall took senior status, we were also hosted for intracircuit sittings in Richmond, Atlanta, and Jackson, Mississippi, which included a visit to historical Vicksburg National Military Park and the Spring Pilgrimage in Natchez. We visited New Orleans twice and attended Mardi Gras. Judge Hall, her law clerks, and I were in Denver for a calendar on that fateful September 11, 2001.

Her law clerks and I were lucky to be the beneficiaries of vicarious travel by way of viewing the many photographs the judge took on her travels to exotic locales while she regaled us with her experiences and displayed her intriguing purchases. We saw polar bears at play and Arctic foxes; learned the difference between species of penguins; admired the grandeur of the Great Wall of China, the Taj Mahal, St. Petersburg, and Japanese pagodas; and were exposed to the people, flora, and fauna of New Zealand, Papua New Guinea, Australia, Africa, the Baltic and Mediterranean Seas, Europe, the Middle East, Asia, Central and South America, the Galapagos Islands, and nearly any other place on earth. For many years it was an annual challenge to select a photograph for her holiday greeting card, but my favorite will always be the lemurs posing like house pets on her shoulder in Madagascar.

Judge Hall had a life as full as one could imagine and has left her imprint not only on the law, but in so many other areas. She worked and played with enthusiasm and was always ready for the next adventure. This brief accounting barely scratches the surface. I am happy to have had the chance to go along for a part of the ride.



Seattle's urban charms notwithstanding, many people choose to explore the region's natural beauty. Seattle is located on the eastern shore of Puget Sound. With snow-capped mountain ranges in the distance to the east and west of the city and water on three sides, there is no shortage of outdoor opportunities. The most visible attraction is Mount Rainier National Park, 90 miles to the south of Seattle. On a clear day, this 14,411 volcano towers over Seattle. Grayline of Seattle operates bus tours from downtown Seattle (<a href="http://www.graylineseattle.com/sightseeingtours.cfm">http://www.graylineseattle.com/sightseeingtours.cfm</a>).

For those interested in setting out on their own, the San Juan Islands are a great day or overnight trip out of Seattle. The San Juans are a small archipelago with beautiful pastoral views, hiking trails, and whale watching opportunities. The many inlets, dense forests, and scenic views make these islands popular with kayakers and bicyclists. Start your explorations in Anacortes, a small fishing and artists' town located 80 miles north of Seattle and easily accessible by car via Interstate 5. Washington State Ferries operates car ferry service out of Anacortes to the major islands. http://www.visitsanjuans.com/index.cfm

Closer to Seattle, the eastern suburb of Woodinville has become Washington's top destination for winery tours. 

# SECURITY ISSUE RE SPOKEO

I happened upon <a href="https://www.spokeo.com">www.spokeo.com</a> and was amazed to find my judge's home address and phone number with just a few clicks. Part of my job is to occasionally check the various web sites to make sure that there isn't any personal information out there or anything threatening to my judge or his family. If you check this site and want to have that information removed as well, here are the instructions provided by Patrick Read, U.S. Marshal. If you check back later and it's still there, contact Spokeo's support team.

- 1) Go to Spokeo.com.
- 2) Search your judge's name and select the profile that matches your information.
- 3) Once you've determined that you've located your profile you can then highlight and copy the URL.
- 4) Find and click on the privacy link on the bottom of the page.
- 5) Paste your URL into the appropriate field, enter your email address, and the provided security code.
  - 6) Click on remove listing.

Spokeo.com obtains the information from public profiles, so if your judge is on any of those sites, Spokeo will generate it again in the future. Pat Read suggested removing your judge's info from the public profile sites as well. One saving grace, however, is that according to Snopes.com, more extensive information available to paid customers of the site is often inaccurate.
