

President's Message

The annual meeting in San Francisco was a fantastic conference. There

were 153 members and 56 guests attending, one of our best turnouts. Once you attend a conference, you are hooked! Many who attended as "first timers" indicated they do not intended to miss another one. Thanks to Erma Smith and her committee, Linda Blandford Gill, Mary Schleier, Donna Peck, Debby Mahoney, Margaret Thomas, Judith Jenkins, Opal Madaris, Marion Mon, Karla Carter, Silva Cohn, Nancy Dick, Heidi Jeannerett, and all our members in the Ninth Their hard work made this an educational as well as enjoyable conference for everyone. I also want to thank Lael Noble for her inspiring leadership last year. It will be a hard act to follow.

The conference in 1996 will be held in San Antonio (on the riverwalk) and the 1997 conference will be in Point Clear, Alabama at the Grand Hotel (on the coast and on a golf course). Plan now to attend. They will both be fantastic!

I have several items of concern that were discussed at the conference. According to the Code of Judicial Ethics (and secretaries are now specifically included in the Code), our association can no longer accept the sponsorships of West Publishing and Mead Data Central in putting on our conferences. We have formed a Ways and Means Committee that will be initiating different methods of raising money for our association. If you have ideas for raising money, please contact the chair of this committee, Shirley Newsome, with your ideas. All committee members are listed in this newsletter. I am sure that you will be hearing more from this committee. "Conference Fund" is being developed. Anyone wishing to contribute may send a donation to our Treasurer, Lana Schultz at Box 2707, Fargo, North Dakota 58108. Incidentally, \$128 was donated by our members at the conference just to start the fund.

I have asked our Treasurer, Lana Schultz, to include a treasurer's report in each of the newsletters. You will see that we are not "flush" with money. Inflation and rising costs in all areas have depleted our funds. Last year our newsletter cost approximately \$1,000 each issue to print and mail. Many of your officers and circuit representatives have personally paid for their own mailing expenses rather than seek reimbursement from the association. A by-law proposal will be sent to you in the future asking for a vote to increase the dues to \$25.00 per year. It was the general consensus at the conference that we cannot continue to efficiently run our association with the minimum amount of dues, and the rising costs we are encountering. We ask your support in this increase.

The Magistrate Judges Secretaries Association held their conference at the same hotel, at the same time, as our conference. The President of the Magistrate Judges Secretaries Association, Linda Altafi, and I hosted a joint reception where both associations met to greet and briefly socialize with each other. Linda and I each briefly spoke of the goals of our association and listed past accomplishments. Dorothy from the Bankruptcy Judges Secretaries Association also spoke. In the future, all three associations, (Magistrates Judges Secretaries, Bankruptcy Secretaries, and FJSA) will send copies of our newsletters to the Presidents of each of the other associations so that we know what is happening in each association. I just received a call today from the President of the Bankruptcy Secretaries Association asking that we bring to our membership the

suggestion that in 1998 all three associations hold their conference at the same time in the same city.

As you may know, the Judicial Resources Committee did not act on our request to equalize the pay of second secretaries to circuit judges. Magistrate judges secretaries, bankruptcy secretaries, district court secretaries, and the first secretary to circuit judges are all graded at the JSP-11. Second secretaries to circuit judges are still at a target grade of JSP-10. The Judicial Resources Committee stated in their report:

Noting the continued interest among judges in pay levels for their secretaries, the committee requested that the Administrative Office facilitate a general review of pay for judges' secretaries by providing for the committee's December 1996 meeting, information on (1) salary market levels for jobs comparable to judges' secretaries, and (2) statistics and other relevant information on recruitment and retention of judges' The committee noted secretaries. that review of this issue in December 1996 would allow two additional budget cycles to pass. Given the budgetary implications of pay changes for a large population group such as judges' secretaries, the passage of two budget cycles could be expected to provide critical information on the judiciary's ability to fund any proposed pay increases.

Because the AO is planning on obtaining their own survey, it is important that we also obtain information as to the salaries of secretaries in comparable positions. Lael Noble, as chair of the Long Range Planning Committee, has agreed that her committee along with the Legislative Committee, will begin working on obtaining information to be submitted. If you have information available or are interested in assisting on this project, contact Lael Noble. interesting comment made at our conference is that "if we could take all the money the AO has spent on surveys that have never been used, we could have funded our raise a long time ago!"

Lael is also putting together a membership manual of all of the secretaries in the United States. If your circuit puts out an employee directory of everyone in your circuit, would the Circuit Representative for each circuit please make a copy of that and send it to Lael. It will aid her in putting together this directory.

The Secretaries Advisory Committee has four vacancies arising. I was informed from Mary Schleier (an FJSA member and a member of the Advisory Committee) that the AO will be sending out a general announcement on how to apply for the vacancies on this Committee. The Advisory Committee has now dropped the Presidents of the three federal secretarial associations as members of the Advisory Committee. They are now observers and can attend the Advisory Committee meetings provided there is funding.

Please remember that anyone can send

information to be printed in our newsletter. It is best if you send it to your Circuit Representative, but if you want to send it directly to the newsletter editor, feel free to do so. However, she would like to receive the material on a diskette with the document formatted for Wordperfect 5.1. Information not received by the newsletter deadlines will not be printed until the next issue. McVeigh has indicated to me that her goal is to make our newsletter as professional and educational as possible. She has put in countless hours already in seeking various bids to keep the cost as low as possible and has put together an agenda for each newsletter. I hope that everyone will give her as much assistance as she is giving the association in putting the newsletter together.

I look forward to serving as your President the coming year, and it is a responsibility I take very seriously. I hope that we can all focus our attention on developing solutions. We can only help to improve our association and our profession by expanding our membership, create networking opportunities, and educating ourselves. But we must do this together. This brings us the opportunity to listen and learn from each other. Your ideas are important; don't be afraid to voice them.

I cannot overemphasize the need for our association. Lately our membership and participation have waned. FJSA needs your help. We are constantly striving for new ideas and better methods for accomplishing our goals. You don't have to be an officer to assist the association. We can all participate by encouraging others to join, by

voting, by supporting our officers, and by doing so we will make our organization strong. The success of FJSA depends on the volunteer efforts of every member. I still need volunteers for the various committees. Please call me if you are willing to work on a committee.

Penny Stautberg is our historian this year. If you have pictures from the conference, please send them to her so that they can be included in our historical book.

Last, but not least, I send my overwhelming thanks to Cathy Cusack, the second secretary in our chambers. She has not only encouraged me, but spent countless hours taking telephone messages, typing lists and letters, critiquing speeches and assisting me in many ways with association tasks. A special thank you also to our officers, circuit representatives, committee chairs and committee members for all of their dedicated efforts.

Secretaries' roles change with downsizing and computer revolution.

Gone are the days of taking shorthand

and typing letters. With computers on nearly every executive's desk, secretaries' tasks have moved to managerial. Due to downsizing, 71% of secretaries now perform duties previously performed by management, says the Administrative Development Institute in Holland, Mich.

"The work has changed totally," says Billie Willey, a secretary at Union Pacific Corp. for 14 years, who now proofreads her boss's typing, creates spreadsheets on the computer and pays the bills. Many secretaries do research on the Internet, purchase large-scale office technology, and even give presentations at business meetings. They typically work for more than one boss, too, since companies now let only the highest executives have a private secretary.

Among the most unusual secretarial tasks, according to the Secretary magazine: snooping on staff members; acting as a decoy in a police sting; and retrieving a boss's undershorts rinsed out and left at a hotel.

In September, 1994, Judge Billings, serving the southern half of Vermont, announced he was taking senior status. Only a couple of weeks later an announcement was made that Chief Judge Fred I. Parker had been appointed to the Second Circuit Court of Appeals. Unfortunately for Vermont, the Second Circuit was able to claim Judge Parker, and for the second time since his appointment, Judge Billings and staff had the unenviable job of handling everything needed handling in Fortunately, Judge Billings, with his thirtyplus years on the Bench (State, Superior Court, and Chief Justice of the State of Vermont) came through with flying colors.



Dr. Gordon Bermant, Director of the Division of Planning and Technology, Federal Judicial Center, addressed the topic, "Technology/Information Highway." He demonstrated some of the changes in court-related communications and automation, and ways evidence is presented and exchanged.

Linda C. McKenzie, Certified Financial Planner, gave an enlightening presentation on investment basics, including financial planning, risk management, taxes, retirement and estate planning, etc.

Nancy Bennett, M.S., R.D., shared the fine art of "Eating Well and Not Wearing It." She discussed ways our bodies store and utilize calories, emphasized the importance of balanced diet and exercise, and suggested some foods that can be substituted for others, if we wish to control our weight and improve our health and energy levels without feeling deprived.


