First Circuit

District of New Hampshire

Chief Judge Sandra L. Lynch of the United States Court of Appeals for the First Circuit announced on September 6 that Bruce A. Harwood has been selected to fill the upcoming vacancy in the United States Bankruptcy Court for the District of New Hampshire created by the announced retirement of Judge J. Michael Deasy. Mr. Harwood will be appointed to the bankruptcy bench in early 2013, upon FBI clearance. He will sit in Manchester, New Hampshire. Mr. Harwood received a Bachelor of Arts degree from Northwestern University and his J.D. degree from Washington University Law School. Mr. Harwood is presently a director and shareholder in the firm of Sheehan, Phinney, Bass and Green in Manchester, where he practices primarily in the areas of bankruptcy and insolvency work. He has a wealth of experience handling all manner of bankruptcy and liquidation issues including representing government agencies, commercial lenders and borrowers, serving as debtor's and creditor's counsel in Chapter 11 bankruptcy reorganizations, appearing in Chapter 7 cases as a trustee and on behalf of secured and unsecured creditors, and representing consumer debtors in Chapter 7 and Chapter 13 cases. Mr. Harwood has provided *pro bono* representation to consumers in need of bankruptcy relief under the auspices of the New Hampshire Bar Association and has been named to the Bar Association's *pro bono* honor roll. He is an elected Fellow in the American College of Bankruptcy and is a director of the American Bankruptcy Institute. Mr. Harwood has authored and published numerous publications in the field of bankruptcy law and has presented many continuing legal education programs. Chief Judge Lynch stated that "the court is extremely pleased that a bankruptcy practitioner of Mr. Harwood's stature will fill this important judgeship. The District of New Hampshire will benefit greatly from Mr. Harwood's knowledge and experience."

I have no additional news to report at this time. As I anticipate ending my representation of the First Circuit this year, please receive my heartfelt gratitude for all your assistance during these years, and know that I will always be around to help in any way I can. Unfortunately, I will not be able to join you at the San Diego Conference. I am sure it will be an interesting, educational and fun experience, and I wish the planning committee and the Board much success. I will miss you all!!

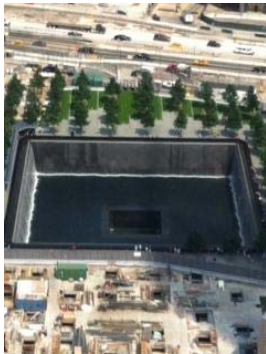
News from around the Second Circuit:

We hope you all enjoyed a wonderful summer! Summer is a busy time for everyone and subsequently, there is not a lot of news to report - but a few newsworthy items do follow:

September 11, 2012:

Events were held throughout the tri-state area to commemorate 9/11. In New York City, a solemn service was held at the reflecting pools at Ground Zero. Moments of silence were held and bells tolled for each specific time that a plane hit the World Trade Center towers, the Pentagon and the field in PA. All of the names of the victims were read aloud by family members and friends. At sunset, the Manhattan skyline was illuminated by twin towers of light - the annual "Tribute in Light," which debuted six months after the attacks and has become a September 11 tradition. Although years have passed, this particular day is always filled with memories of those lost. I hope the families and friends of victims find comfort in knowing that the entire nation feels their pain and that even though years have passed, we have not forgotten!

The attached pictures were recently taken from the 41st floor room of a hotel across the street from Ground Zero. As you can see, progress is literally coming up out of the ground! The reflecting pools are operational with the names of all victims etched into the marble surrounding the pools. Trees are planted and thriving. The One World Trade Center building can now be seen from as far away as central NJ, and is on its way to becoming the tallest building in America! The new transportation hub (for subway and PATH trains) is taking shape. The entire downtown area is robust and filled with life again. It is a testament to our unwavering spirit - we were not defeated, and we are coming back stronger than ever!



Court of Appeals:

On May 1, 2012, the Federal Bar Council held its annual Law Day Dinner. At the dinner, the Learned Hand Medal for Excellence in Federal Jurisprudence was presented to the Honorable Robert A. Katzmann, U.S. Court of Appeals for the Second Circuit. In his remarks, Judge Katzmann expressed his gratitude to the Federal Bar Council for their support of the Study Group on Immigrant Representation, which Judge Katzmann started in 2008. 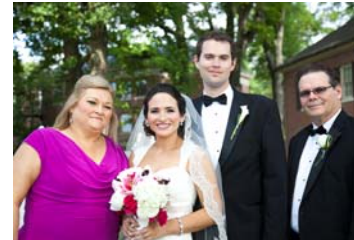

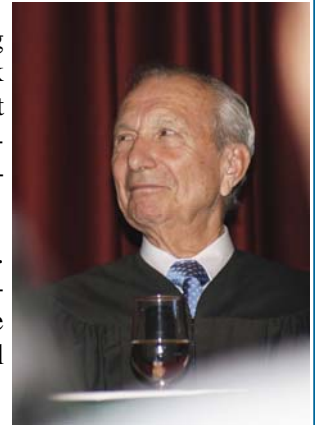

Hello Ninth Circuit FJAA Members?

Sandra Day O'Connor, the first woman justice on the U.S. Supreme Court, visited Anchorage on September 5, 2012, to promote her iCivic program.

iCivics is an interactive online program that Justice O'Connor founded to promote civic education around the country because she is concerned that young people do not seem to understand how our government works. iCivic includes programs for the judicial, legislative, and executive branches of the government, and is designed primarily for a middle school audience. While here, she visited Anchorage's Central Middle School and West High School. A reception for the public at large was held at the Dena'ina Civic and Convention Center where Justice O'Connor presented remarks on Revitalizing Civic Education in America.

UNITED STATES COURT OF APPEALS FOR THE D.C. CIRCUIT

A portrait ceremony for Senior Judge Douglas H. Ginsburg will be held on September 28, 2012, as well as for Senior Judge A. Raymond Randolph to be held on November 2, 2012. Chief Judge David B. Sentelle will have his portrait ceremony on April 5, 2013.

UNITED STATES COURT OF APPEALS FOR THE FEDERAL CIRCUIT

The Honorable Richard Linn will retire from regular service and assume senior status on November 1, 2012. Judge Linn has served on the Court for over twelve years. He was nominated to the Court by President Clinton and took the oath of office on January 1, 2000. Judge Linn is a long time patent attorney and began his patent law career as an examiner at the United States Patent & Trademark Office. In recent years, Judge Linn has been instrumental in developing an alliance of intellectual property focused inns of court known as the "Linn Inn Alliance."

The Honorable Arthur J. Gajarsa retired from the U. S. Court of Appeals for the Federal Circuit on June 30, 2012. Judge Gajarsa led a distinguished judicial career during which he served the judiciary and his nation with honor and excellence.

Judge Gajarsa's parting message to the Court was the following:

"It has been indeed an honor and privilege to have worked with all of you during the past 15 years. You made my work at the Court easy to perform and a pleasure to undertake. My success and the success of the Court are attributable not only to my judicial colleagues, but also to the fine members of the court team. I shall miss all of you and I look forward to observing the continued fine work of the Court in the future. I am looking forward to retirement as of June 30, not as the end of my career, but the beginning of a new one."

The Historic United States - China Intellectual Properties Adjudication Conference took place in Beijing, China on May 28, 2012. It was attended by prominent jurists, government officials, lawyers, academics and business leaders from the United States and China. The purpose of this three-day event was to discuss the adjudication of intellectual property disputes. There were over 1,200 attendees, including seven Circuit Judges of the United States Court of Appeals for the Federal Circuit, seven judges from the Intellectual Property Rights Tribunal of the Supreme People's Court of the People's Republic of China and nearly 300 other judges from the Chinese judiciary. Over 100 American lawyers, law school professors, corporate counsel and United States State Department and Patent Trademark Office officials also attended. Many lawyers from the China Law Society and over 100 law students from Renmin University also participated in the event. This was the first time that leading American and Chinese jurists, lawyers, academicians and high government officials have met in a public forum to discuss and share common intellectual property issues.

Speakers from the United States included Judge Randall R. Rader, Judge Raymond C. Clevenger, III, Judge Richard Linn, Judge Timothy B. Dyk, Judge Sharon Prost, Judge Kimberly A. Moore and Judge Jimmie V. Reyna. Other speakers were the United States Ambassador to China, Gary Locke, Director of the United States Patent and Trademark Office, David Kappos, and President of the Federal Circuit Bar Association, Steven C. Lambert. The three-day US-China IP Adjudication Conference was deemed a great success. Issues of common interest in the three major areas of intellectual property law, patent, trademark and copyright were reviewed and discussed as well as matters of mutual interest. All those who participated in the Conference recognized the historical importance and merit derived from this unique event.

I have now finished the paralegal program!!!! My last class was a course entitled "Litigation Technologies."

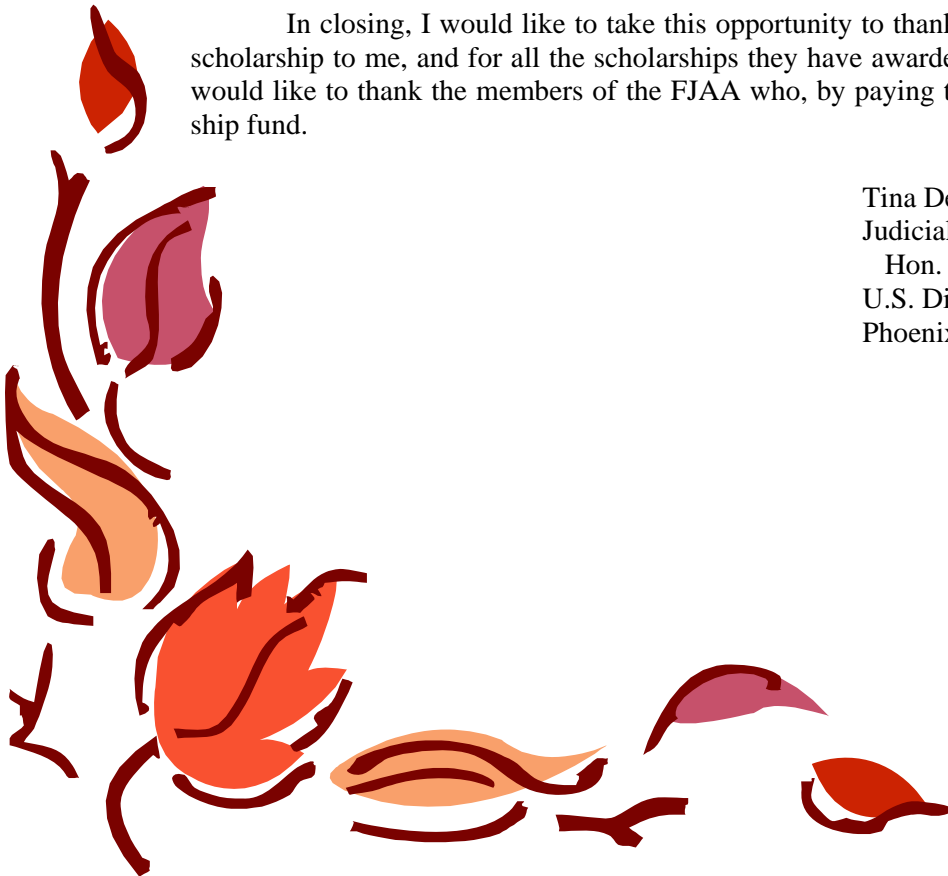
One of the objectives of this class was to learn about various electronic software packages in order to develop a working knowledge of technology as it relates to today's law office. In that connection, we worked with several interactive tutorials and gained hands-on experience with several of the electronic software packages. These software packages included PowerPoint (presentation software); Tabs3 (timekeeping and billing software); AbacusLaw (case management, docketing, and calendaring software); CT Summation iBLAZE (litigation support software); LexisNexis Case Map (knowledge management and litigation support analytical software); Time Map (litigation support software that creates visual timelines and time maps); and Trial Director (electronic trial presentation software).

In addition, we discussed ethical issues as they relate to paralegals. A few of those issues included keeping electronic client information confidential; keeping e-mails secured from unauthorized interceptions; maintaining appropriate password protections on computers and documents; maintaining appropriate firewall and antivirus protections on computers; maintaining appropriate theft protection for laptops and flash drives; deleting metadata from documents before they are sent out; and making sure all client documents contain the correct information for that particular client.

The Committee disbursed scholarship awards for the first half of 2012 to Tina DeMonaco in the amount of \$248.00, Tracy Diaz received \$120.00 and Marcy Gatell received \$382.00 for a total of \$750.00 out of the \$1500.00 budgeted for scholarships this year. There were no applications received for the second half of the year.

When making an application for a scholarship, please remember to provide the **exact** amount that you are requesting and documentation to support the request. The deadlines for applying for a scholarship are **May 31 and August 31**. If applications are sent by mail, they must bear dates no later than these dates as the postmarked date. No extensions will be granted. Applications are accepted through email, regular mail and fax to the chair of the committee. Applications postmarked after May 31st or August 31st will not be considered.

I would encourage all members to take advantage of this wonderful program to enhance your skills and personal growth. The more diversified a person is, the better chance of keeping our jobs in the uncertain future for Judicial Assistants. This does not cost a member anything, other than the time it takes to fill out the application.

Below is some additional information on the scholarship program:

The FJAA Scholarship Program is administered by the Professional Development & Continuing Education Committee (PDCEC) to enable and assist members in good standing to pursue their educational goals and professional development by taking courses and attending seminars and workshops to provide additional knowledge and skills to enhance job performance.

Unless otherwise approved by the Executive Committee, the minimum amount allocated for the Scholarship Program per calendar year shall be \$500.00. Any monies not awarded in a calendar year will not be carried over to the next year.

The amount awarded per individual scholarship may vary as determined by the PDCEC, depending upon the available funds at the time of the application process. A member may apply for funding for more than one course/program, however, priority will be given to members who have not previously received a scholarship.

The course or training program for which the scholarship is used does not have to be applied toward a degree, but must be work or career-related so that the courts as well as the individual recipient benefit.

Upon completion of the course, seminar or workshop, the scholarship recipient shall write a brief article for the FJAA Newsletter ("*In Brief*") and provide proof of successful completion of the program to the PDCEC.

If the scholarship recipient does not successfully complete the program for which funds were provided, the recipient will be required to return the funds to the Scholarship Program.

The approval of applications and a decision as to the awards shall be made by PDCEC no later than July 15th and September 30th respectively.

The applicants will be notified by phone or e-mail by July 15th and September 30th respectively.

Should one of the members of the PDCEC be an applicant, the President or someone appointed by the President, shall substitute for the PDCEC member in reviewing the applications.
