Although it is too late to be entered in the "early bird" \$100 membership drawing give away, it's never too late to encourage a fellow JA to support our organization with their membership. A few reasons a Judicial Assistant should join:

Our Association speaks for us at a national level. A recent example is the October 2015 joint correspondence with the Association of Bankruptcy Judges Assistants to the Office of Personnel Management on our behalf concerning the OPM cyberattack requesting "that lifetime credit monitoring be offered all those affected by this comprehensive security breach. Three years of credit-monitoring and identity-theft insurance is completely inadequate."

Our Association supports our educational endeavors. Our Scholarship Program awards money annually to JA's who are continuing their paralegal studies, higher education, etc. It is open to every member in good standing who wishes to apply for this opportunity. Additionally, our annual conference provides training and professional development. Associated costs, subject to approval by your Court, are eligible to be paid through use of Chambers Training Funds.



One of our association goals is to exchange practical information. In that spirit, I offer this timesaver. On any given day I receive and send dozens of email messages. It is important to quickly identify messages that need preferential treatment, i.e. messages from my Judge, our case manager, etc. Our Court uses Lotus Notes email and I found a function that allows color-coding mail messages for easy sender identification. It is simple to set color preferences following these steps:

Click **File**, click **Preferences**, click **Mail**, and select the **Sender Colors** tab. Type in the "Sender names", select your "Background" color from the drop down box. Click "OK" and the identifying color is applied.

"The Chief and I" Charlene R. Gill - Michigan Eastern District

You know how life sometimes throws you those unexpected curve balls that change what you think is your destiny? Well, as a "Baby Boomer" who swore she'd never stay at any job more than five years (gotta keep it moving, you know?), I never thought that my journey would come to a full-fledged stop more than 23 years ago when I encountered the one person who has undoubtedly changed my direction and point of view - Judge Denise Page Hood.

Judge Hood previously served on the Michigan state court benches of 36th District Court, Recorder's Court and the Wayne County Circuit Court (which is where I began working as her assistant, shortly after her nomination to the federal bench by President Bill Clinton). I'd never worked in the legal field before but, through a twist of fate which was actually engineered by her husband (now, that's another story), Judge Hood offered me the position that ultimately re-routed my life. She was confirmed by the Senate in 1994 and asked me to join her as she ascended to the United States District Court for the Eastern District of Michigan. What an honor for me!

Judge Hood presently serves as Chief Judge of the Eastern District of Michigan, a title which she attained on January 1, 2016. A few weeks later, she was administered the oath at one of the largest ceremonies ever held here at the Courthouse. It still amazes me to know that over 700 colleagues, family, friends and Court Family were in attendance to observe and support her as she became the third female to lead our Court as Chief, and the second African American female to do so. It was quite an event and certainly well-deserved.

Judge Hood currently serves on the Criminal Pattern Jury Instructions Committee for the 6th Circuit and the Criminal Rules Advisory Committee of the U.S. Courts. She has served on several District Court Committees: Pro Bono; Local Rules; and Ad Hoc Jury. She is an active member of several professional organizations: Immediate Past Co-Chair of the Michigan State Planning Body for legal services; the State Bar Pro Bono Initiatives Committee; and the Detroit Metropolitan Bar Association Foundation Board. She is past president of the Detroit Bar Association and the Association of Black Judges of Michigan. In addition, Judge Hood serves as a volunteer in various community groups including: vice chair of the Olivet College Board of Trustees; the Harper-Hutzel Hospital Board of Trustees; and the InsideOut Literary Arts Project Board.

Judge Hood has received numerous honors including, most recently, the 2016 Damon J. Keith Soul and Spirit Humanitarian Award. She is a graduate of Yale University and Columbia University School of Law. She is married to the Reverend Dr. Nicholas Hood, III, Senior Minister of Plymouth United Church of Christ in Detroit. They have two sons.

Judge Hood is a highly respected jurist among her peers and to those who happen to have the good fortune to cross her path - whether in front of the bench, behind the bar or in the community. The epitome of fairness and patience, her "judicial temperament" defies the standard. Yes, she is now Chief of our Court, but there are so many other words that describe this woman, most of them beginning with the word "phenomenal." If you've already met her, you know what I mean. If you haven't, well, you're in for a treat.



Project Home: Making Dreams Come True!

Imagine that you are a recently released convicted felon. You find employment and have a steady income. You think about purchasing a home, but you do not have sufficient funds for a down payment. No one in your family has ever owned a home -- why should you be any different? You convince yourself that homeownership is impossible.

The U.S. Probation Office in the Eastern District of Missouri started Project Home in 2007. The mission: to educate ex-offenders that home-ownership is possible. To that end, Project Home assists interested ex-offenders in becoming homeowners through education and coordination with state and federal resources.

Hundreds of ex-offenders have participated in the home-ownership education program since 2007. Many participants are currently establishing or repairing credit in preparation for the goal of home-ownership. To date, forty-five ex-offenders have obtained homes!

Nebraska

On Monday, March 21st, the Supreme Court declined to hear Nebraska and Oklahoma's proposed lawsuit against Colorado's legal marijuana laws. Even though the Supreme Court declined to hear the case, the plaintiff states can still take their cases to U.S. District Court.



Pocatello judge nominated for federal bench

District Judge David Nye of Pocatello was nominated by President Barack Obama Tuesday to serve in the U.S. federal court for the District of Idaho. The nomination comes after a cooperative selection process between the White House and Idaho's Republican Sens. Mike Crapo and Jim Risch.

"I am pleased to nominate Judge Nye to serve on the United States District Court bench," President Barack Obama said in a White House press release. "I am confident he will serve the American people with distinction."

While the president nominates federal district judges, state Sens. Crapo and Risch have veto power. So

Nye's nomination was the result of a lengthy selection process carried out by Idaho's senators — both of whom are lawyers.

Nye, born in San Jose, Calif., moved to Idaho after completing his bachelor's and law degrees at Brigham Young University in Utah. For 20 years he worked as an attorney with the Merrill & Merrill firm in Pocatello before being appointed as district judge by Gov. C.L. "Butch" Otter in 2007.

"We're very proud and lucky to have him as a judge in our county," said Bannock County Prosecutor Stephen Herzog. "We'll be sad to lose him."



In Pocatello, Nye oversees the divisionary felony drug court.

"He's very qualified and I've always found him to be very level-headed and fair," said Herzog. "He's well-versed in the law and treats everyone respectfully. If I were to be judged I would have no problem with him judging me."

Ninth Circuit News Continued...

With the White House and Senate currently at odds over the Senate's refusal to hold hearings on Judge Merrick Garland — Obama's nomination for the Supreme Court — the confirmation of federal judges has been slow at best.

However, in a press release, Crapo said that he felt confident he could get Nye's nomination confirmed.

"As I have told the president, I am committed to working diligently and enthusiastically to obtain the consent of the Senate for Judge Nye's confirmation," Crapo said in a press release.

Idaho was forced to use out-of-state judges to hear Idaho cases after U.S. district Judge Edward Lodge took senior status in July, leaving just District Judge Lynn Winmill in the District of Idaho. The federal courts declared it a "judicial emergency."

After receiving his Juris Doctorate from University of New Mexico School of Law, Judge Carson began his legal career in 1999 as law clerk for Judge Bobby R. Baldock of the United States Court of Appeals for the Tenth Circuit. After completing his clerkship, he worked first as an associate and then as a partner for one of New Mexico's most established energy law firms. Judge Carson later served as General Counsel to one of New Mexico's largest employers and producers of oil and gas for several years before starting his own law firm, Carson Ryan LLC. As a part-time Federal Magistrate, Judge Carson continues his private practice which focuses on legal issues related to the energy industry and problems faced daily by corporations and their employees.

Judge Carson resides in Roswell, New Mexico with his wife, Dr. Karen Carson and their two sons, J.C. and Chris. In addition to his private practice and part-time judgeship, Judge Carson competes in National Cutting Horse Association competitions in New Mexico, Arizona, Colorado, and Texas. His passion for the westernstyle equestrian sport is matched only by his wife and two sons, who tend to fare better in competitions than the Judge!

Judge Carson's courtroom deputy, Rachel Tutor, is prepared for the challenges the new position entails. She began working for Judge Carson in 2001 and has transitioned with him throughout his legal career. OKLAHOMA NEWS:

A dedication ceremony held Friday, February 12, 2016, at the Oklahoma City federal courthouse, officially renamed the building after the longest sitting judge on the Tenth Circuit Court of Appeals in Denver. The federal appellate judge, William J. Holloway Jr., was born in Hugo, Oklahoma and graduated from the University of Oklahoma. United States Court of Appeals DC Circuit

On March 16, 2016, President Barak Obama nominated Chief Judge Merrick Garland to serve as an Associate Justice of the Supreme Court. Judge Merrick, if confirmed would fill the vacancy created by the late Justice Antonin Scalia.

Chief Judge Garland was appointed to the United States Court of Appeals in April 1997 and became Chief Judge on February 12, 2013. He graduated summa cum laude from Harvard College in 1974 and magna cum laude from Harvard Law School in 1977. Following graduation, he served as law clerk to Judge Henry J. Friendly of the U.S. Court of Appeals for the Second Circuit and to U.S. Supreme Court Justice William J. Brennan, Jr. From 1979 to 1981, he was Special Assistant to the Attorney General of the United States. He then joined the law firm of Arnold & Porter, where he was a partner from 1985 to 1989 and from 1992 to 1993. He served as an Assistant U.S. Attorney for the District of Columbia from 1989 to 1992, and as Deputy Assistant Attorney General in the Criminal Division of the U.S. Department of Justice from 1993 to 1994. From 1994 until his appointment as U.S. Circuit Judge, he served as Principal Associate Deputy Attorney General, where his responsibilities included supervising the Oklahoma City bombing and UNABOM prosecutions.

United States Court of Federal Claims

A number of senior judges were welcomed back to the bench for 90-day periods of recall service: Judge Loren A. Smith began his service on January 19, 2016; Judge Robert H. Hodges, Jr., on February 1, 2016; Judge Robert J. Yock on April 1, 2016; and Judge Bohdan A. Futey on April 18, 2016.

Judge Lawrence J. Block retired on Jan 8th, 2016. Judge Block was confirmed to the United States Court of Federal Claims on October 2, 2002. Prior to his confirmation, from 1994 to 2002, Judge Block served as Senior Counsel to the Senate Judiciary Committee, where he worked on a number of significant issues, in-cluding property rights legislation, punitive damages and class action court reform bills, costbenefit analy-sis regulatory reform, tobacco policy, litigation and arbitration policy. He also worked on issues involving the First Amendment, privacy, and other constitutional provisions arising out of legislation and governmen-tal programs related to high technology.

2016 FJAA Conference Minneapolis/St. Paul, Minnesota September 8-11, 2016




