

Prior to joining the Court, the Hon. Michael Vazquez was a partner at Critchely, Kinum & Vazquez, LLC, from 2008 to 2016. Judge Vazquez worked in the Office of the Attorney General for the State of New Jersey where he served as Special Assistant to the Attorney General and afterwards as First Assistant Attorney General from 2006 to 2008. Next, he was an Assistant United States Attorney in the United States Attorney's Office for the District of New Jersey from 2001 to 2006. Host Intern/Law Clerk Summer Program

Every year, the U.S. District Court for the District of New Jersey hosts a intern/law clerk summer program. This year's program commenced June 8th and will conclude on July 20th. Every week, the program schedules two guest speakers on different days to talk about a topic relating to their line of work. This year's guest speakers include Magistrate, District and Appellate Court Judges, Federal and State Court attorneys, the U.S. Attorney, Criminal and Civil Attorneys, a former Governor and a Training Specialist. Sessions are held in a Judge's courtroom and is scheduled during lunchtime. Therefore, the staff are encouraged to bring a brown bag lunch to consume while they listen to a guest speaker talk about a specific subject area. For example, on June 8th, the Hon. Katharine S. Hayden, United States District Judge, spoke regarding "An introduction to Federal Courts in the District of New Jersey".

Prior to the interns and law clerks's attendance, an email was circulated to all with a copy of a pamphlet addressing the many components of our court system. At the conclusion of each session, the interns and law clerks are encouraged to ask questions

The last day of the program is reserved for a tour of the Northern State Prison where the court staff arrives at 8:30 a.m. until 12:30 p.m. For security reasons, the prison will only allow 25 people to tour it. The staff have to undergo a clearance by completing a form "Application for Clearance". In addition, attire must be kept in a modest fashion. I hear this is quite a popular event and from the quick response to confirm attendance, you will see what I mean. An email was circulated to the Judge's Chambers and within 9 seconds, 25 people replied. This beats out last year's record of 2 hours. Everyone who was fast enough to respond I'm quite sure is very happy to have made the list.

FOURTH CIRCUIT—BARBARA BARRY




HONORABLE SOL BLATT, JR. AUGUST 20, 1921—April 20, 2016

U.S. Senior District Court Judge Sol Blatt, Jr., at the age of 94, left this mortal Earth and in so doing left a huge void in the lives of all he touched at the courthouse and far beyond. Sol Blatt, Jr. (pronounced /blot/) was the grand-son of a Russian-Jewish immigrant, and the son of one of the most powerful South Carolina state representatives who served in the House of Representatives for 53 years, 33 of them as its speaker. Judge Blatt grew up in the small western South Carolina town of Barnwell, attending public school there and graduating from the University of South Carolina in 1941.


While at South Carolina he was president of the student body and a member of the boxing team, winning the Southern Conference lightweight title. He was a true Gamecock and attended every rival Carolina-Clemson football game for 88 years only missing 3 years due to his military service in World War II. He earned his law degree from the USC School of Law and practiced law at his father's firm for 25 years before being appointed to the federal bench in 1971 by President Richard M. Nixon. Judge Blatt served as chief judge from 1986-1990, and senior judge from 1990-2016. He served 45 years as a federal Judge, and in 2006 became the longest serving federal judge in South Carolina history. In order to mark this great milestone, the federal judges in South Carolina signed a resolution naming Judge Blatt's courtroom in Charleston, the Sol Blatt, Jr. Courtroom, and a brass plaque outside this historic courtroom bears his name. It should also be noted that he is the longest serving judge in the Fourth Circuit of U.S. Courts. Everyone who knew Sol Blatt, Jr. loved and respected him, and the respect he received was directly proportional to the respect he showed for everyone with whom he came into contact.

He wasn't interested in making headlines but instead strove to be a fair, courteous and intelligent federal judge. Judge Blatt was a humble and unassuming man who loved life and people and embraced life to the fullest each day. A local newspaper after his passing described him as "a living legend and known widely for his fairness, gentleness and stamina." His dear friend and former law clerk (1977- 1979), Ed Westbrook, gave a beautiful grave-side eulogy to a standing room only gathering, wherein he described Judge Blatt as a man who gave much love, encouragement, wisdom and joy to many and asked little in return, and appreciated every small thing anyone did for him. He went on to list lessons Judge Blatt taught to include, don't wait to show people you love them, don't be arrogant, age is a state of mind, and don't shout to be heard loudly. Lawyer Westbrook (this was how Judge Blatt addressed lawyers he admired)



recalled from the 1939 movie "The Wizard of Oz" where the wizard tells the Tin Man, "A heart is not measured by how much you love but by how much you are loved by others." Sol Blatt, Jr.'s heart was enormous - it gave and received boundless love. Representative Joe Wilson, on the floor of the House of Representatives 3 days after Judge Blatt's death declared, "Indeed, it was as if the American Bar Association had him in mind when it outlined the tenets of judicial temperament: 'compassion, decisiveness, open-mindedness, sensitivity, courtesy, patience, freedom from bias and commitment to equal justice."' Judge Blatt's chambers could not have run efficiently and smoothly for 45 years without the loyal support and friendship of his assistant, Janice Pearce, a member of FJAA. My life is better for having known Judge Blatt for the past 21 years I've been at the federal court, and I miss him every day as does everyone at the federal courthouse in Charleston. He is survived by 3 children, 6 grandchildren and 5 great-grandchildren.

Barbara M. G. Lynn took the oath of office as a United States District Judge for the Northern District of Texas on February 14, 2000. Upon her graduation from law school, she joined the Dallas law firm of Carrington, Coleman, Sloman & Blumen-thal, LLP, and remained there until she took the bench.

She was listed in the Best Lawyers in America in Business Litigation from 1994-99 and was designated by the National Law Journal in 1998 as one of the fifty most influential women attorneys in the country. In 2004, Judge Lynn was recognized as Judge of the Year by the Dallas Chapter of the American Board of Trial Advocates.

Judge Lynn is married to Michael P. Lynn, a Dallas trial lawyer at Lynn Pinker Cox & Hurst LLP. They have two daughters and two granddaughters.








News from a few states that comprise the Eighth Circuit

ARKANSAS

United States District Courts and Judges of Arkansas, 1836-1960

He also served on the Bankruptcy Appellate Panel for the Eighth Circuit from 1996 until 2016. Judge Kishel has been active in the Minnesota State Bar Association, National Conference of Bankruptcy Judges, and the American Bankruptcy Institute. In 2013, he received the Minnesota State Bar Association's Judge Nancy C. Dreher Pro Bono Distinguished Service Award. Congratulations, Judge Kishel!

Nevada Bar Awards Highest Honor to

Chief Judge Emeritus Procter Hug, Jr.

RENO, NEVADA – The State Bar of Nevada has awarded its highest honor to Chief Judge Emeritus Procter Hug, Jr., of the United States Court of Appeals for the Ninth Circuit. The 2016 Presidential Award will be presented to Judge Hug on June 8, 2016, at the Washoe County Bar Association's

annual meeting here.

Judge Hug is completing his 39th year of service on the nation's busiest federal appellate court.

Nominated by President Carter, he came onto the Ninth Circuit bench on September 15, 1977. He served as chief judge of the circuit from 1996 to 2000 and assumed senior status in 2002. He currently ranks third in seniority among the court's 44 judges.

In announcing the selection of Judge Hug for the prestigious award, the state bar noted his tireless efforts to preserve the geographic and organizational integrity of the Ninth Circuit. Throughout his tenure and particularly while serving as chief judge, Judge Hug worked closely with members of the U.S. Senate in heading off attempts to split the Ninth Circuit.

The state bar announcement quoted Senator Harry Reid of Nevada, who expressed his admiration of

Judge Hug as a "a great Nevadan."

"His impact upon the law in the western United States is unsurpassed by any other Nevada lawyer,"

Senator Reid said. "He can truly be described as the man who saved the Ninth Circuit."

Prior to coming onto the federal bench, Judge Hug had been in government service as a civilian aide to the secretary of the Army in 1977; as general counsel to the University of Nevada System, from 1972 to 1976; and as a deputy attorney general for the State of Nevada. He had practiced law in his native Reno from 1958 to 1977.Judge Hug received his B.S. from the University of Nevada, Reno, in 1953 and his LL.B. from Stanford Law School in 1958. He served in the Navy from the 1954 to 1955.

The State Bar of Nevada's Presidential Award is presented annually to a member practicing 20 years or more whose conduct, honesty and integrity represents the highest standards of the legal profession. Award recipients are those who inspire by example, advance the administration of justice, and bring honor and integrity to the profession. PAGE 20
