

Welcome to Terry Manning, JA to Judge Allison D. Burroughs, U.S. District Court, Boston, Massachusetts

Terry's career with the government spans over 34 years. She came to the judiciary from the U.S. Attorney's Office in Boston, MA where she had worked with Judge Burroughs when the judge was an AUSA. Terry has worked with various government agencies over the years, including the Department of Health, Education and Welfare, the Department of Interior, Fish and Wildlife Service and the Department of Justice, U.S. Attorney's Office, Drug Task Force Unit and Criminal Division. In 1995 she briefly left the federal government for a position as Administrative Assistant to the Sheriff of Middlesex County, Mass. In May 1997 she returned to the U.S. Attorney's Office to serve as Administrative Assistant to U.S. Attorney Donald K. Stern. Terry later joined the Economic Crimes Unit where she worked until February 2015, when she joined the court. Terry enjoys traveling, bowling, shopping, and most of all spending time with her sisters and their families.

Judge Allison Burroughs was sworn in as a U.S. District Judge for the District of Massachusetts on January 7, 2015. She received her J.D. from the University of Pennsylvania Law School. Prior to joining the bench, she was a partner in the Boston firm of Nutter, McClennen & Fish. Before that, she worked in the Boston and Philadelphia offices of the United States Attorney. During her 16 years as an AUSA, she developed trial and investigation expertise in sophisticated while collar and economic crimes. Judge Burroughs began her legal career as a law clerk for U.S. District Judge Norma Shapiro in the Eastern District of Pennsylvania. Remarking on her appointment, Chief Judge Saris said, "Judge Burroughs fills the seat left vacant when Judge Rya Zobel took senior status, and is the fourth new judge on the Federal District Court confirmed in the past year. We are excited to have her energy and vast civil and criminal litigation experience."

We wish Terry and Judge Burroughs all the best in their positions with the court and look forward to getting to know Terry as a member of the FJAA!

The following press release concerning the elevation of Judge Jeffrey Howard to Chief Judge of the First Circuit Court of Appeals was recently announced:

THE HONORABLE JEFFREY R. HOWARD NEXT CHIEF JUDGE OF THE FIRST CIRCUIT COURT OF APPEALS

BOSTON (June 16, 2015)—On Tuesday, June 16, 2015, the Honorable Jeffrey R. Howard became the tenth chief judge of the Court of Appeals for the First Circuit, a position created by Congress in 1948. The chief judge of the circuit assumes the position based on seniority, as authorized by 28 U.S.C. § 45. Chief Judge Howard succeeds Judge Sandra L. Lynch, who has served with distinction as Chief Judge for her seven year term. Judge Lynch remains on the Court of Appeals in regular, active service. Upon assuming the office Chief Judge Howard stated, "I am humbled to be entering this position of enormous trust among my colleagues on the Court of Appeals. I am grateful that I enter the office with the knowledge that the courts of the First Circuit are held in the highest regard, thanks to the fine judges and public servants who staff those courts, and especially because of the tireless efforts of outgoing Chief Judge Sandra Lynch, whose reputation as a brilliant judge and national leader in court administration has been a credit to our circuit."

A native of New Hampshire, Chief Judge Howard has served on the First Circuit Court of Appeals for 13 years. He was nominated by President George W. Bush on September 4, 2001, and received his commission on May 3, 2002. Before joining the federal judiciary, Chief Judge Howard spent much of his career serving the state and federal governments, first in the Office of the New Hampshire Attorney General in the 1980s as an Assistant Attorney General, and then Deputy Attorney General. In 1989, Chief Judge Howard became the United States Attorney for the District of New Hampshire, and in 1991 was designated Principal Associate Deputy Attorney General of the United States Department of Justice, holding both positions until 1993 when he returned to state service as the Attorney General of the State of New Hampshire until 1997. Subsequently, Chief Judge Howard was a partner at Choate, Hall & Stewart. As a judge on the First Circuit Court of Appeals, Chief Judge Howard has served on the Judicial Conference Committee on Criminal Law and the Committee on the Judicial Branch."

We extend our congratulations to Judge Howard and his Judicial Assistant, Lynne Woodward.

District of Connecticut:

On April 26, 2015, the Honorable Lorraine Murphy Weil passed away at the age of 68. Judge Weil was sworn in as the first female United States Bankruptcy Court Judge for the District of Connecticut in 1999 and her chambers were located in New Haven, CT. Judge Weil retired as Chief Judge of the U.S. Bankruptcy Court of the District of Connecticut in 2013. We send our sincerest condolences to Judge Weil's family.

On June 1, 2015, 482 people from 91 countries took the oath of citizenship in the largest naturalization ceremony ever held in the State of Connecticut. U.S. Magistrate Judge Joan Margolis convened U.S. District Court at Woolsey Hall at Yale University, New Haven, CT, in order to accommodate the large group. Several officials spoke at the event, all of whom had family immigration stories of their own to tell. Yale University's President, Peter Salovey, spoke of his paternal grandfather, who was from Jerusalem, and his grandmother, who was born in Poland. U.S. Senator Richard Blumenthal, D-Conn, spoke of his father, who came to America at age 17 in 1935, fleeing persecution in Germany, speaking no English and arriving with little more than the clothes he was wearing. Even Judge Margolis spoke of her grandparents, who left Czarist Russia in 1905. She told the new citizens that "America is you," referring to the long history of immigration to the United States. She also told the group "We need your heritage, we need your culture, we need your beliefs, because that is what makes America great, *you* are what makes America great." Congratulations to all involved in making this naturalization ceremony the *huge* success that is was!

On June 30, 2015, U.S. Magistrate Judge Thomas P. Smith, who sits in Hartford, Connecticut, retired after more than 35 years on the bench. Judge Smith is the longest-sitting U.S. Magistrate Judge in the Second Circuit, which is comprised of Connecticut, Vermont and New York. He graduated first in his class of 137 at the University of Connecticut School of Law in 1972 and is the first University of Connecticut Law School graduate to be appointed a U.S. Magistrate Judge. Magistrate Judges are federal trial court judges who are appointed to the court for eight-year terms. Judge Smith is in his fifth eight-year term. Before his appointment, Judge Smith was a federal prosecutor for the U.S. Department of Justice and a professor of contract law. He also taught an undergraduate law course at Trinity College in Hartford for 23 years. We thank Judge Smith for his many years of dedicated service, and wish him much happiness and personal ful-fillment in his retirement!

Maryland

There has been a redesign of the District of Maryland courthouse in Greenbelt, Maryland! The court was facing a space emergency with three district judges taking senior sta-

tus, their replacements coming on board, and a growing misdemeanor docket. The court was short on chambers and courtrooms. In 2011, led by then Chief Judge Deborah K. Chasanow an innovative solution was planned that would maximize use of the existing space. The end result, a chambers suite that will accommodate five judges and staff, was revealed in May. In addition to offices, the suite includes shared conference rooms, copy and file/storage areas, as well as a large kitchen/break room. The judicial assistants share a common area in the center of the suite. A special design touch was the use of glass for the interior walls that gives the suite an airy feel. FJAA Conference in Charleston, S.C. Transportation Information


For members attending the annual conference in Charleston, the following ground transportation information might be of interest:

Transportation can be obtained at the airport to the Francis Marion Hotel. You will need to exit the airport through the baggage claim area to the shuttle stand outside. There you will get on a shuttle or take a taxi to downtown. Shuttles usually cost \$12-\$15 per person and a taxi will be \$30-35. The shuttles and taxis are awaiting arriving passengers so there shouldn't be any problem getting one immediately.

When you are leaving the Hotel to go back to the airport, you can sign up for Mitch's shuttle service at our front desk. He will go directly to the Airport without stops. We schedule the return shuttle on the half hour and hour. We suggest leaving $1\frac{1}{2}$ hours before your departure time. Shuttle will be \$15 per person if two or more are traveling at the same time in the shuttle or \$30 for one person.

Microsoft Word Tips

Shrink to Fit

When you write a document in Word 2010 and your document is just a few lines too long to fit onto one page, you can use the Shrink to Fit option (Shrink One Page) to quickly reduce the document to one page. Shrink to Fit will reduce the font size of the document to the point where the document fits on one less page than it would use.

The Shrink to fit command is available in Word 2002, 2003, and 2007. In Word 2010 the option is not available on the ribbon or the quick access toolbar. However, you can customize the ribbon and add the command Shrink One Page to a new or existing group.



New Federal Re-entry Court in Alaska Aimed at Reducing Recidivism

Federal officials in Alaska have established a "re-entry" court aimed at reducing the number of offenders' relapses into criminal behavior. "The goal is to reduce recidivism, but really it's to help people reclaim their lives in a crime-free and a drug-free lifestyle," said U.S. Magistrate Judge Deborah Smith, who was credited by colleagues with heading up the effort to establish the court. The U.S. District Court for the state set up the Alaska Hope Court by general order on May 29.

Re-entry courts are meant to closely manage people after they are released from prison, using court authority to steer them toward resources and offer feedback. It's like a team of guidance counselors for felons trying to re-establish their community ties. That includes ensuring participants enroll in substance abuse or mental health treatment and helping them meet essential needs like housing and employment.

Research shows recidivism can be reduced through such assistance, officials said.

All federal defendants on probation and those who have completed their sentences and are on supervised release can volunteer for the re-entry court, with the exception of sex offenders. Smith said the exclusion of sex offenders is typical in similar courts nationwide. But they could be added in the future, she said. As of May 29, the re-entry court team had identified 17 potential participants. All six of the people asked to join the pilot project so far had agreed. The first court session was set for June 25.

The Revolving Door

U.S. District Court Judge Timothy Burgess said he and others involved in setting up the re-entry court were interested in trying something new after dealing with the same offenders multiple times. "It came from a basic frustration of seeing people come back to court too often after they've already been through the criminal justice system," said Burgess, who serves as the re-entry court's committee chair. The team felt it was important to get involved earlier in the lives of recently released inmates and help them break bad habits, he said.

"Once people have served their sentence and paid their debt to society, as is often said, we all still have a role to play when helping offenders transition back into the community, so we don't see them again and start the whole process over," said first assistant U.S. Attorney Kevin Feldis. The court system spends a lot of money dealing with people who break their release conditions, said federal public defender Rich Curtner.

Studies: Re-entry courts reduce recidivism

This is the third attempt to start a federal re-entry court in Alaska. The previous two attempts, Judge Smith said, were halted by concerns about effectiveness and availability of resources. This time, a subcommittee reviewed numerous re-entry and therapeutic courts in federal districts with caseloads similar to Alaska's. They also looked at the state's therapeutic courts, officials said.

The re-entry team required that the Alaska court be founded on empirical evidence. "We wanted to make sure we had a program that fit our (criminal) court and our community," Curtner said. "It was a matter of shopping and trying to come up with our own plan."

The subcommittee's report says there are more than 2,300 courts nationwide seeking to solve the problems presented by defendants with substance abuse issues and addictions. The bulk of these are called drug courts. Several studies have found that drug courts reduce crime. One such study concluded that for every dollar spent on drug courts, the criminal justice system saves more than \$2 in the long run, the report says.

Continuing dialogues

Judge Smith said she and her colleagues agree there should be swift sanctions for re-entry court participants who fail to follow the rules. The severity of the sanctions varies and can include things like a few days of jail time for a positive drug test. "That seems to be a very valuable feature," Smith said.

U.S. Magistrate Judge Kevin McCoy said that in criminal court, dialogue between judge and defendant often ends when a judge starts to detail why the defendant is being sentenced. Offenders tune out the court, said McCoy. Re-entry court will allow for greater interaction between judges and defendants, he said.

"What this program has that I don't have now is the opportunity to acknowledge someone's accomplishments and not just their failures," Burgess said.

Senate Panel Approves Judge for California Courthouse

The Senate Judiciary Committee on [June 4, 2015] overcame its frequent partisan rancor to recommend filling a crucial Fresno-based judicial seat, handily approving the nomination of U.S. Magistrate Judge Dale A. Drozd as a U.S. District Court Judge. The committee's action on voice vote clears the way for Drozd's elevation to a life-tenured position in the Eastern District of California, with final Senate approval possible at any time.

"I am so pleased that the Judiciary Committee approved Judge Drozd, an exceptional nominee who has a proven track record as a magistrate judge in the Eastern District for the last 18 years, including as chief magistrate judge for the last four years," Democratic Senator Barbara Boxer of California said in a statement. If confirmed by the full Senate, as now appears probable, the 60-year-old Drozd will replace U.S. District Judge Anthony Ishii. Ishii took senior status in 2012, a kind of quasi-retirement position in which he can choose to take cases, or not.

A graduate of San Diego State University and UCLA School of Law, Drozd was originally appointed as magistrate judge in the Clinton administration. "He is well regarded in the legal community and among those who appear before him on a daily basis," said Democratic Senator Dianne Feinstein of California, a member of the Senate Judiciary Committee.

He formally retired on July 31, 1997, and continued to serve the Court during periods of recall as a Senior Judge.
