Recipe Corner



Pumpkin Bread - Submitted by Mellissa Schoenbein, CDIL

This is a recipe from my stepmother who passed away in 2002. I like to make it every fall because it reminds me of her and fills my house with the smell of pumpkin spice. Although her recipe didn't call for it, I like to add $\frac{1}{2}$ cup of semi-sweet chocolate chips.

Mix together the following:

2 eggs

1/3 cup vegetable oil

1/3 cup water

1 cup pumpkin (from can of 100% pure pumpkin)

Then add the following:

1 2/3 cups flour

1/4 teaspoon baking powder

1 1/3 cup sugar

3/4 teaspoon salt

1 teaspoon baking soda

1 teaspoon cinnamon

2 teaspoons ginger

1 teaspoon cloves

1/2 cup semi-sweet chocolate chips (optional)



Grease bread pan with butter. Bake at 325 degrees for 60-80 minutes, or until toothpick inserted in the center comes out clean. Makes 1 loaf. If making muffins, bake for 20 minutes.

San Francisco Courthouse Exhibit

Celebrates The Recorder's Bygone Editorial Cartoons

Consider it visual evidence that federal judges in the Northern District of California are committed to the First Amendment: Hanging outside the 18th floor library at the federal courthouse in San Francisco is an exhibit of a decade's worth of editorial cartoons from *The Recorder* depicting the district's judges—and not always in the most flattering light.

The exhibit was the brainchild of the San Francisco District Court library staff, which enlisted the help of frequent cartoon subject U.S. District Judge Charles Breyer for logistical help choosing cartoons and finding funds for framing.

The court's exhibit features the works of George Riemann, who illustrated cartoons for *The Recorder* from the early 1990s until the newspaper ceased print publication in September 2016. Riemann estimates that he worked with about a dozen different *Recorder* editors over the period, first in-person at the paper's offices and then via phone and email once he moved to Germany in 2001.

"The editors would come up with an idea and then give it to me in a few lines or sentences by email or phone," said Riemann via email. "While listening on the phone, I would sketch out a very rough scenario, which often stayed pretty much the same until the end."

Breyer said that there were probably some judges who — either by conduct or appearance — lent themselves to Riemann's work more often. "George has a way of getting to the heart of a matter in caricature that's remarkable and tweaks a judge and prods a judge."

The exhibit's organizers say it will remain in place indefinitely and visitors are welcome.





French Apple Cake

Nancy Nelson, law clerk for Magistrate Judge Camille D. Bibles in Flagstaff, AZ

Ingredients:

- $1\frac{1}{2}$ pounds Granny Smith apples, each peeled, cored, cut into 8 wedges, and wedges sliced 1/8 inch thick crosswise
- 1 tablespoon Frangelico (optional)
- 1 teaspoon lemon (or orange) juice
- 1 cup (5 ounces) plus 2 tablespoons all-purpose flour
- 1 cup (7 ounces) plus 1 tablespoon granulated sugar
- 2 teaspoons baking powder
- ½ teaspoon salt
- 1 large egg plus 2 large yolks
- 1 cup vegetable oil
- 1 cup whole milk
- 2 teaspoons vanilla extract
- 2 tablespoons fresh-grated orange or lemon peel (optional)

Instructions:

Adjust oven rack to lower-middle position and heat oven to 325 degrees.

Spray a 9-inch springform pan with vegetable oil spray (or grease with vegetable oil). Place prepared pan on rimmed baking sheet lined with aluminum foil.

Place apple slices into microwave-safe pie plate (I use a glass pie plate), cover (with parchment or a paper towel or a plate), and microwave until apples are pliable and slightly translucent, about 3 minutes.

The microwaved apples should be pliable but not completely soft when cooked. To test for doneness, take one apple slice and try to bend it. If it snaps in half, it's too firm; microwave it for an additional 30 seconds and test again.

Toss apple slices with Frangelico and lemon juice and let cool for 15 minutes. You can substitute brandy or rum or......for the Frangelico.

Whisk 1 cup flour, 1 cup granulated sugar, baking powder, and salt together in bowl.

Whisk egg, oil, milk, and vanilla together in second bowl until smooth. Add dry ingredients to wet ingredients and whisk until just combined.

Transfer 1 cup batter to a separate bowl (or glass measuring cup) and set aside.

Add egg yolks to remaining batter and whisk to combine. Using spatula, gently fold in cooled apples. Transfer batter to prepared pan; using an offset spatula, spread batter evenly to pan edges, gently pressing on apples to create even, compact layer, and smooth surface.

Whisk remaining 2 tablespoons flour into the reserved batter. Pour over the batter already in the pan and spread batter evenly to pan edges and smooth surface. Sprinkle remaining 1 tablespoon granulated sugar evenly over cake.


Bake until center of cake is set, toothpick inserted in center comes out clean, and top is golden brown, about 1 and 1/4 hours.

Transfer pan to wire rack; let cool for 5 minutes.

Run paring knife around sides of pan and let cool completely, 2 to 3 hours.

Dust lightly with confectioners' sugar, cut into wedges, and serve.


The Honorable Kea Whetzal Riggs, U.S. District Judge "No Stranger to the Bench"

The Honorable Kea Whetzal Riggs is no stranger to the bench. Prior to her nomination and appointment as a District Judge of the United States District Court for the District of New Mexico, she was appointed as a U.S. Magistrate Judge for the District of New Mexico on April 13, 2001 and served in that capacity until her appointment by New Mexico governor, Susana Martinez to the role of state district judge for the Fifth Judicial District of New Mexico on August 8, 2014. She received her commission as a United States District Judge on December 31, 2019 and assumed her duties in January 2020.

Judge Riggs earned her Bachelor of Business Administration from the University of Oklahoma in 1987 and her Juris Doctor from the University of Oklahoma College of Law in 1990. In addition to her experience as a federal and state judge, she has served as a prosecutor, with a focus on violent crimes, and as guardian ad litem for abused and neglected children in the foster care system of Chaves County, New Mexico. She also has served as an adjunct professor at Eastern New Mexico State University–Roswell during the periods of 2001–2002, 2008–2009 and 2012–2014 and at New Mexico Highlands University–Roswell from 2006–2009 and in 2011.

Most recently, Judge Riggs successfully held the first jury trial in the district, since the proliferation of COVID-19, while ensuring the safety of jurors, counsel and court personnel through the observation of both local administrative rules and guidelines and recommendations set forth by the Centers for Disease Control (CDC).

"Strong passion for the Judiciary"



The Federal Judicial Assistants Association (FJAA) was formed in 2002, as a result of a merger between the Federal Judges Secretaries Association (which was formed in 1972) and the Federal Magistrate Judges Secretaries Association (which was formed in 1995). In 2009, the Federal Judges Secretaries Association officially changed its name to the Federal Judicial Assistants Association.

The Federal Judicial Assistants Association has held annual conferences since 1973, in Washington, D.C., Denver, Las Vegas, Seattle, St. Louis, Memphis, and San Francisco, as well as many other wonderful locations.
