Northern District of New York:

The Honorable Brenda K. Sannes was sworn in as U.S. District Judge for the Northern District of New York on December 4, 2014. Judge Sannes filled the seat vacated by Judge Norman Mordue, who assumed senior status in June, 2013. Her chambers will be located in Syracuse, NY. Judge Sannes is the second female Northern District Judge to be based in Syracuse (the first was Judge Rosemary S. Pooler, now with the U.S. Court of Appeals for the Second Circuit), and is only the third female appointed in the history of the Northern District (Judge Mae D'Agostino, Albany, NY, was the second female appointed)! Judge Sannes received her B.A. from Carleton College and her J.D. from the University of Wisconsin-Madison. At the time of her appointment, Judge Sannes was serving as an Assistant U.S.

Attorney for the Northern District of NY, a position she held from 1995-2014. She has also worked as an Assistant U.S. Attorney for the Central District of California, as an attorney with a firm in Los Angeles, CA, and clerked for the Honorable Joseph Farris of the Ninth Circuit. We send Judge Sannes our congratulations, along with a warm welcome to the Second Circuit!

On January 21, 2015, Clerk of the Court for the Northern District of New York, Lawrence K. Baerman, celebrated 35 years of service with the courts. Mr. Baerman, as they say, "worked his way up through the ranks." He began his service working in the Clerk's Office as a clerk, worked as a Courtroom Deputy, and then became Clerk of Court. For those who are not aware, the Northern District of New York encompasses federal courts in Albany, Binghamton, Plattsburgh, Syracuse and Utica, New York. District Court of Connecticut:

On October 30, 2014, the District Court of Connecticut convened in ceremonial session to celebrate the 225th Anniversary of the creation of the U.S. District Court for the District of Connecticut, and to celebrate the 100th anniversary of the Richard C. Lee U.S. District Court Courthouse, located at 141 Church Street, New Haven, CT. As guests entered the courthouse, they were welcomed by the University of New Haven Chargers Marching Band, playing various musical selections. Chief Judge Janet C. Hall opened the ceremonial session. Judge José A. Cabranes, Second Circuit Court of Appeals and former Chief Judge of the U.S. District Court for the District of Connecticut, delivered the opening remarks and enlightened all with his history of the Court entitled "On the Mythology of the Mother Court." Professor John Fabian Witt, of Yale Law School, was the keynote speaker, and delivered his remarks entitled "Transformation or Continuity? Reflection on the Federal District Court for the District of Connecticut on the 100th Anniversary of its New Haven Courthouse." Prof. Witt's remarks were accompanied by a wonderful slide show further depicting the architecture and building of the courthouse. The crowd was also treated to musical interludes by the Unity Boys' Choir, a wonderful choir comprised of boys from communities in and around New Haven. They sang a beautiful "Patriotic Medley" and a touching rendition of "America the Beautiful." Following the ceremony, a reception was held on the second floor of the courthouse where posters were on display marking historical events in the life of the Court, and everyone was invited to view the recently renovated historic courtroom, which has been in use since 1918. It is stunning! Happy Anniversary to the District Court of Connecticut!

The Honorable Victor A. Bolden was confirmed as U.S. District Court Judge for the District of Connecticut on November 20, 2014, and took the oath of office on January 7, 2015. At the time of his appointment, Judge Bolden was serving as Corporation Counsel for the City of New Haven, CT, a position he held from 2009-2014. Prior to that, he was Assistant Counsel and General Counsel for the NAACP Legal Defense and Education Fund, and also worked at the law firm of Wiggin & Dana. Judge Bolden succeeded U.S. District Court Judge Janet B. Arterton, who assumed senior status in July. Judge Bolden's chambers are located in Bridgeport, CT. On December 19, 2014, the District Judges selected Sarah A. Merriam, Assistant Federal Public Defender, to become a U.S. Magistrate Judge. Magistrate Judge Merriam will replace Magistrate Judge Holly B. Fitzsimmons, who will retire on April 2, 2015. Magistrate Judge Merriam's chambers will be located in New Haven, CT. The Court of Appeals welcomes its newest member to the Court, Cheryl Ann Krause. She was appointed to the United States Court of Appeals for the Third Circuit in July, 2014. She obtained her undergraduate degree from the University of Pennsylvania, summa cum laude, and graduated from Stanford Law School with distinction. After graduation, she served as a law clerk to the Honorable Alex Kozinski of the United States Court of Appeals for the Ninth Circuit and the Honorable Anthony M. Kennedy of the United States Supreme Court. After her clerkships and before her appointment, Judge Krause was in private practice, served in the United States Attorney's Office for the Southern District of New York, and was a lecturer at Stanford and Columbia Law Schools. She also taught several courses at the University of Pennsylvania Law School, where she founded an appellate litigation externship program.

Judge Krause has served on the boards of many professional, civic, and charitable organizations. In 2011, she founded the Philadelphia Project, a partnership between Dechert LLP and the Public Interest Law Center of Philadelphia to improve the quality of education for children with disabilities.

On November 21, 2014, the Honorable Madeline Cox Arleo was sworn in as District Judge for the District of New Jersey. Prior to that, she served as a Federal Magistrate Judge in Newark, NJ, for fourteen years. She also serves as presiding judge of the recently established "ReNew" reentry court for the United States District Court, in which she oversees intensive supervision of individuals who are serving terms of supervised release, with the goal of reducing recidivism.

Prior to her appointment to the bench, Judge Arleo was in private practice, served as an Adjunct Professor of Law at Seton Hall University School of Law, and was the Secretary to the District V-A Ethics Committee. Judge Arleo received her undergraduate degree in English and Political Science from Rutgers College, Rutgers University, in New Jersey, and her master's degree from the Eagleton Institute of Politics at Rutgers University. She graduated *summa cum laude* from Seton Hall University School of Law, where she served as Editor-in-Chief of the Law Review. She was a law clerk to the Honorable Marie L. Garibaldi, New Jersey Supreme Court. Judge Arleo is a Fellow of the American Bar Association, an Advisor to the Historical Society of the U.S. District Court for the District of New Jersey and to the Association of the Federal Bar for the District of New Jersey. She serves on the Paralegal Studies Advisory Board at Montclair State University. She has previously served on the Board of Trustees of her alma mater, St. Dominic Academy, an all-girls high school in Jersey City, New Jersey, and presently is a member of the Board of Trustees of its sister school, Mount St. Dominic Academy in Caldwell, New Jersey.



Tulane Law School Hall of Fame

The Honorable W. Eugene Davis was recently elected to the Tulane Law School Hall of Fame.

The Hall of Fame was created in 2013 as a way of celebrating the remarkable and exceptionally talented individuals who have been connected with Tulane Law School, either as alumni or faculty, during its 168-year history. Elections are made by a selection committee comprised of distinguished alumni and the Dean.

Judge Davis was first appointed to the U.S. District Court for the Western District of Louisiana in 1976 by President Gerald Ford. In 1983, President Ronald W. Reagan elevated Judge Davis to the U.S. Court of Appeals for the Fifth Circuit, where he serves today.



He is a former member of the Advisory Committee on Criminal Rules of the U.S. Judicial Conference, which he chaired for four years. He is also a member of the American Bar Association, the Maritime Law Association of the United States, and the Louisiana Bar Association. Judge Davis has been actively involved with LSU Law, serving as presiding judge in the final round of the Robert Lee Tullis Moot Court Competition during the 2007–2008 academic year. Judge Davis is a native of Alabama who earned his undergraduate degree from Samford University in Birmingham, Alabama. He obtained his L.L.B. degree from Tulane University Law School in 1960. Upon graduation, he practiced law with the Phelps Dunbar law firm in New Orleans, and then from 1964–1976 with the firm of Caffery, Duhé and Davis in New Iberia, Louisiana. He and his wife Celia reside in New Iberia.

This year's class will be inducted at the Annual Alumni Luncheon, to be held at the New Orleans Marriott Hotel on Friday, March 27, 2015.

Once again the Eastern District of Louisiana Federal Court in New Orleans collected toys for the Forgotten Angels Party. The event is planned by a local homeless shelter, Ozanam Inn. 2014 JUDICIAL CONFIRMATIONS - NORTHERN DISTRICT OF ILLINOIS

On Wednesday evening, April 30, 2014, the United States Senate confirmed the nomination of Manish S. Shah as U.S. District Judge for the Northern District of Illinois.

Juris Doctorate from The University of Chicago Law School in 1998. After law school, Shah was an associate at Heller Ehrman White & McAuliffe, where he primarily worked on antitrust litigation. From 1999 to 2001, Shah served as a law clerk to the Honorable Judge James B. Zagel in the United States District Court for the Northern District of Illinois. Shah then joined the United States Attorney's Office for the Northern District of Illinois as an Assistant United States Attorney, where he worked in General Crimes (2001-2003), Narcotics & Gangs (2003-2004), and Public Corruption (2004-2007). He was then promoted to Deputy Chief of General Crimes in 2007 and later of Financial Crimes & Special Prosecutions in 2008. In 2011 he was promoted to Chief of Criminal Appeals. Shah currently serves as Chief of the Criminal Division, a position he has held since 2012.

On September 19, 2013, President Obama nominated Shah to a seat vacated by Judge Joan Lefkow, who took senior status, in the United States District Court for the Northern District of Illinois. He received a hearing before the Senate Judiciary Committee on November 13, 2013, and his nomination was reported to the floor of the Senate on January 16, 2014, by voice vote. He was sworn in by Judge Zagel on June 26, 2014.

JUDGE JORGE ALONSO

Jorge Alonso was recommended by U.S. Senator Dick Durbin (D-IL) to fill the vacancy created when Judge Ronald A. Guzman became a senior judge.

Judge Alonso has served as an Associate Judge of the Circuit Court of Cook County since 2003. He currently serves in the Criminal Division and also presides over a specialty court program for women with mental illness in the criminal justice system. He previously worked for over eleven years as an Assistant Public Defender in the Office of the Cook County Public Defender. He is a graduate of the George Washington University Law School. Judge Alonso was sworn in December 19, 2014.

JUDGE JOHN BLAKEY

U.S. Senator Mark Kirk (R-III.) applauded the Senate's confirmation of John Blakey, Senator Kirk's recommendation to be a judge for the U.S. District Court for the Northern District of Illinois.

Blakey is the Chief of the Special Prosecutions Bureau at the Cook County State's Attorney's Office and Special Assistant United States Attorney at the U.S. Attorney's office. He was Senator Kirk's recommendation to fill the vacancy created when Judge James F. Holderman became a senior judge at the end of last year. Judge Blakey was sworn in December 30, 2014.

Judge Sidney Thomas Takes Ninth Circuit Helm

SAN FRANCISCO (CN) - Chief Judge Sidney Thomas grasped Judge Alex Kozinski in a bear hug Friday as he took the gavel in a ceremony marking his transition to the job of 11th chief judge of the country's largest appellate circuit.

"I could not be handing it over to a better man, a better person, a better human being," Judge Kozinski said, who leaves the post after a seven-year term.

The 61-year-old Thomas, who lives in Billings, Montana, is the third Montanan to hold the position. He joins Judge James R. Browning, who was chief judge from 1976 to 1988, and Judge Walter Lyndon Pope, who served for one year in 1959. In his remarks, Thomas acknowledged his friend Browning, who died in 2012.





"He befriended me from the moment I was on the court. Seven years ago I sat down here with Judge Browning and as the gavel was passed, he grabbed my arm and said 'I want to be here in seven years when you take the gavel.' He didn't make it, he came a couple of years short. But I hope I can emulate his wisdom and his style."

The modesty and quiet nature for which Judge Thomas is well-known was reflected in his remarks, much of which he spent thanking his family, friends, and colleagues on the court, and paying homage to his beloved Montana.

"I'm privileged to be able to live in Montana and serve in the Ninth circuit, and it reminds me a bit of what Odysseus said to the Phaeacians just before he came back to Ithaca. He talks about Ithaca and says mine is a rugged land but it's a good land for raising sons. I for myself know no sweeter sight on earth than a man's own native country and that's the way I feel about Montana and that's the way I feel about the Ninth Circuit," Thomas said. "When I joined the Ninth Circuit I expected to find brilliance and scholarship, but what I didn't expect to find was some of the best friends I have in life. We have our differences, but our differences are interesting and important. When we finish our cases, we care for each other's families, we care for each other's dogs, we take care of ourselves through joys and sorrows. It is a court family, and I'm proud to be a part of the collegiality of the Ninth Circuit."

The standing-room only audience at the James R. Browning Courthouse in San Francisco included Thomas' wife Martha, sons Oscar and Skeff and his two sisters, as well as Martha's two sisters, and her brother and his wife. "And that's just the immediate family," U.S. District Judge Dana Christensen of Montana said, laughing. He added, "There are over 50 of Sid's former and current law clerks. This is remarkable. I think that speaks so highly of what the people who have worked with Judge Thomas think of him."

Judge Kozinski also noted the packed audience, joking, "I guess word got out that I was stepping down as chief judge." He later joked about his term, saying, "Not everybody gets to serve. I made it by dint of age, years of service and having deftly avoided impeachment."

Senior Judge Michel Daly Hawkins, who spoke at the ceremony, poked fun at Judge Kozinski. "Seven years ago, Alex Kozinski was standing at this podium with a twinkle in his eye, thanking his colleagues for voting for him as chief judge," Hawkins said. "We don't vote for chief judge. If you're young enough and you're on the court long enough, you sort of ascend to the position."

Judge Thomas ascended to the position by virtue of being the most senior active judge under the age of 65, in what Hawkins called "a peaceful transition that can be likened to going from Clint Eastwood to Gregory Peck." He added, "So now a tall Montanan takes the helm. Like Alex, he's young of heart and mind. He's deliberate, with a firm grasp on the long view. What you really get with Sid Thomas is character. It's a character born of a lifetime of living in and understanding the great expanse and uniqueness of the west."

Judge Thomas said he will not move to San Francisco, where the Ninth Circuit is based, but will maintain his chambers in Montana and commute to California.

Do You Believe in Miracles?

It has been more than 20 years now since that knock on our door. At 2:00 a.m., our son's girlfriend and her mother drove over to our home to inform us that our son had been shot! "Shot?" "How?" "When?" He was in high school then and had asked to stay overnight with some soccer buddies. We knew the kids and their families too, so we thought it a "safe" choice. We found out later that the group left the home they were staying at to drive into town for something to eat. We also learned they had been drinking, which kids will do, which can add an element of "courage" to situations - and it did in this one too.

The fight began with shouting, challenges, then fighting. A group of soccer buddies against a group of kids they did not know. One of the kids from the other group left and came back with a gun. Our son turned when the shot was fired. Had he not turned, the bullet would have hit the center of his heart. He was shot, however, parallel to his heart – exactly on the opposite side. With no time to waste, his friends drove him to the E.R. The E.R. staff was able to stabilize him – they saved his life. The doctors opted not to remove the bullet, not knowing if the surgery would cause more internal damage. The bullet remains lodged in his chest today.

As we rushed to the hospital to see our son, not knowing the extent of his injuries, I remembered reading somewhere that our children are our gifts, and that we should cherish and nurture these gifts. My mind was telling me that if we had to let him go, we would. That it would be hard, it would hurt, but if we had to let him go, we would. My heart, however, was not ready. A collapsed lung, a chest tube, a week and a half of painful intensive care. I never left his side, reminiscing on the day he was born and all the memories in between - from his birth, to this day. He was only in high school, I thought, he is too young. An extremely bright son, bold, boisterous and strong-willed. I hoped now that these traits would pull him through the pain and that he would be strong enough to survive the shooting. Hoping, praying, and believing.

He left the hospital weak, but strong. He fully recovered, continued to play soccer, a goalkeeper, and he *finally* finished high school. He started (but has not finished) college. He worked odd jobs, year after year, never truly finding his niche.

He's married now, to a beautiful and caring wife, the father of two and expecting their third child. Still bright, bold, and strong-willed, carrying the constant reminder of what *could have* happened, His destiny - to become a Deputy U.S. Marshal. He, along with his peers (and a younger brother who is also a U.S. Marshal), protects the Federal Judiciary, our staff, our buildings, transporting prisoners, apprehending fugitives, safeguarding Federal witnesses.

So, to the working mothers and fathers of our Court family - who continually strive to balance our work and home lives; raising our children and grandchildren in a world filled with crime, drugs, guns, and violence, cherish your children, nurture them, be patient with them. They are our greatest gifts. The scar of that day is forever etched on my heart – the scar of the MIRACLE!

CHAMBERS STAFF TRAINING FUND

The Chambers Staff Training Fund (CSTF) is a centrally-held source of funding provided to the courts in the amount of \$400 per chambers staff member. (Example: Judge + Judicial Assistant + 2 Law Clerks =\$1,600.) Each court determines how it will utilize the funds. A court may choose to split the fund evenly among each chambers staff member or a court can use the entirety of their portion of the fund on just a few staff members. The CSTF may be used for any managerial, operational, or administrative training, but cannot be used on legal training. The training can be from a public or private sector provider (i.e. outside of the training provided by the AO, FJC, or other government source).

This fund is available for use by Judicial Assistants to pay for travel and training held in conjunction with the private association meetings like the FJAA Annual Educational Conference or the Association of Bankruptcy Judicial Assistants (ABJA) Annual Educational Conference. Some districts "pool" the training funds and permit Judicial Assistants to apply for the funding to cover the cost of their travel, hotel and registration. Other districts allot an equal amount to each Judicial Assistant attending a conference.

The Chief Judge of your district has the authority to approve use of the CSTF. The funds do not "roll over." If the funds are not used in one year, those funds do not accumulate to the next year. Most training that judges and law clerks attend is funded by the AO or the FJC. Members of the clerk's office are not eligible to use this funding for training.

This is a real opportunity to educate our judges on CSTF and their availability. Traditionally, the CSTF is underutilized by chambers staff. Please take time to educate yourself and your judges about CSTF. The funding is available for your use in FY15. I encourage you to apply to use the funds to attend the FJAA Annual Educational Conference in September, 2015 in Charleston, South Carolina.

When a surname ends in s, x, ch, sh, or z, add es to form the plural.

Mr. and Mrs. Jonesthe JonesesMr. and Mrs. Coxthe CoxesMr. and Mrs. Welchthe WelchesMr. and Mrs. Marshthe MarshesMr. and Mrs. Hernandezthe Hernandezes

NOTE: Omit the *es* ending if it makes the name awkward to pronounce:

Mr. and Mrs. Hodges are the Hodges, not the Hodgeses. Mr. and Mrs. Hastings are the Hastings, not the Hastingses

Showing possession depends on which of the above formats was used.
